I, SI Kousik Banerjee, O/C, Boro PS, Dist- Purulia do hereby lodge the complaint against the following persons namely (1) Sandip Om S/O Lt. Boro, Dist - Purulia and 200/250 persons. It is to mention that today (01/04/2020) at 08.35 hrs I received an information that the Ration Dealer of Ankro village namely Shibaprasadh Mandal S/O- Lt. Gour Kishor Mandal was distributing the food articles at lesser quantity. About 800 -900 people of the village assembled near the shop and tried to manhandle the dealer. Accordingly myself along with ASI Sankar Brahma, ASI Janrdan Kumar, C/994 Srikanta Kumbhakar, C/1243 Abodh Mahato, C/358 Ganesh Ch. Roy, C/297 Apurba Pandey and C/1481 Gadadhar Biswas rushed to the spot vide Boro PS GDE No. 13 and 14 dated 01/04/2020 & CC no 664 and 666 dated 01/04/2020 with the detailed Govt. vehicle bearing registration no WB-42S- 4996. Myself along with force arrived at the spot and found that approx 800-900 public are gathering in front of the Ration Shop. I tried to control the situation and also tried to recover the ration dealer from this place but the local public create obstruction of my work. Accordingly I informed the matter to the BDO Manbazar-II Development Block, SDPO Manbazar and CI Manbazar. BDO Manbazar-II arrived at the spot with inspector of food and supply and CI Manbazar also reached and tried to convince the people that appropriate action will be taken against the dealer and we also tried to convince them about the lock down situation regarding the COVID-19. When the dealer was detained by us and was taking him to the police station the Govt. vehicle, about 200-250 people sat on the road and started demanding

his punishment there itself. SDPO Manbazar reached at the spot with his reserve force and the assault group from Head Quarter, Purulia and tried to convince the people again that at present assembling of people may be a threat to life but they did not listen and a few people started picking brick / stone in their hand and started to throw brickbats/ stone on the police force with a view to kill us and in that one Govt. vehicle windshield was broken and ASI Janrdan Kumar, C/358 Ganesh Ch. Roy, C/297 Apurba Pandey and C/1481 Gadadhar Biswas received grievous injury on their body. Heaving no other option a mild force was applied to disperse the public and to take the detained dealer to P.S. after returning at P.S. the injured persons were treated at Basantapur P.H.C. with the help of others.

Case No. 16/2020 dated- 01.04.2020 U/S 147/ 148/ 149/ 186/ 188/ 269/ 270/ 323/ 326/ 307/ 353/ 427/ 332/ 333/ 109/114 IPC read with section 15 (A)(b) of the West Bengal Maintenance of public (Order) Amendment Act. 2017 and section 3 / 4 of PDPP Act., 1984. SI Manas Dutta will investigate the case.
