Sir,

In producing herewith one Tractor registration No-WB-55A/6327 with Sand loaded trolley as per seizure list. I SI Partha Sarathi Shit of Hura PS lodged a complaint against the owner and driver of the seized tractor. To the effect that on 01/04/2020 at 01:15 Hrs. while I was engaged night mobile duty at PS area received a source information from my reliable source that one tractor with trolley mentioned above was coming from Kansai River side towards Hizuli having loaded with sand without any royalty/challan. This information communicated to O/C Hura PS for onward transmutation. As per direction of O/C Hura PS, I SI Partha Sarathi Shit and force namely 1) Constable-633 Dasarath Singh Mura, 2) Constable-118 Dijapada Mahato, NVF- 908 Lakhindar Singh Mura rushed to the spot to work out the source information. We reached at near Chaknada Village at 02:05 hrs on village Road from Nischindapur to Chaknada we found that one tractor with trolley coming towards me. After seeing police the driver of the tractor and stop the tractor in a distance then driver able to flee away. Then I rushed there and found the said tractor loaded with sand approx 100 Cft. and no body found with the said tractor. I waiting some reasonable times but nobody turned up. It is learnt from the source that the owner and the driver of the tractor stolen away sand from Kansai River bed in a clandestine manner and they are involved in illegal business for gain. Accordingly I seized the offending vehicle, NX3037 New Holland Tractor having Reg No- WB-55A/6327, Eng No-S325H73561, Chassis No-NHN30370ZHF392942 with approx 100 Cft sand loaded trolley after preparing proper seizure list duly signed by accompanied Police persons because of unavailability of the local people due to owed hours of night.

Therefore I request that a specific case may kindly be registered against the owner and driver of the seized vehicle Reg No- WB-55A/6327 under proper section of law and arrange for its investigation.
