As per Govt. circular, the political program irrespective of all political parties are restricted in this pandemic situation. On received the such information reached there and on seeing police van they all managed to escape from there. CVF Jagannath Kumbhakar & CVF Taraknath Bouri who were engaged traffic duty at Ladhurkamore opposed them not to do the such type of program and also taken some photographs about their assembled. Local enquiry revealed that above noted persons assembled there with their banner (CPIM).

Moreover all the persons were making and circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people and as well as the society and give provocation to the people to break public peace or to commit other offence making conspiracy. They also disobeyed the Government Order regarding recent pandemic situation for attacking of Corona virus throughout the India as well as whole World.
