Sir,

I, SI Hemanta Kr. Sahababu of Jhalda P.S. returned to PS with force and brought under seizure 1) one black colour Pulsar Motor Cycle having No- WB56M 8726, 2) one black & white colour Hero Honda Passion Plus Motor Cycle having No- WB56C 8100 and 3) one black & white Hero Honda Splendor Plus Motor Cycle having No- JH01P 7211 and lodged this complaint against (i) Dayaram Mahato (21) S/O Lt. Radan Mahato of Mathari (Khamar), PS-Jhalda, Dist-Purulia (ii) Ganapati Lohar (24) S/O Lakhan Lohar of vill- Olgara, PS-Jhalda, Dist-Purulia (iii) Santosh Gorain (23) S/O Lt. During Day Mobile duty as per direction we were engaged for implementation of Govt. rules regarding Lockdown and disaster management plan. During Mobile duty received source information that some persons of Jhalda PS area came from different working places to their home and local people are very much afraid of spreading COVID 19 virus. I informed the matter to I/C Jhalda PS and as per direction myself with force went to their homes, examined them. During examination they disclosed their identity as noted above and admitted that violating Govt. order they came from their working places to their home crossing border of Jhalda PS. It was also known that they were working at different places of Jharkhand state like Tata, Ranchi, Silli and Kolkata. During interrogation it is known that SL No- i) to iii), v), vii) and xii) came from Tata, SL No- iv), vi) and ix) came from Ranchi, SL No- viii) came from Muri, SL No- x) came from Kolkata, SL No- xi) came from Kashmar. In the view of pandemic disease COVID-19 Govt. promulgated Lockdown order and they were staying at their working places. Knowing all the direction of Govt. they came out from their working places and crossed border of Jhalda P.S. jurisdiction secretly and reached their home and disobeyed Govt. order and committed negligent act likely to spread infection of diseases dangerous to life and violated Quarantine rule. So, I arrested them

maintaining all formalities of arrest and later on released on bail considering present situation of epidemic COVID-19. I also arranged for their medical test at Jhalda BPHC and as per advice of M.O. of Jhalda BPHC I kept them at KARMATHIRTHA, Institutional Quarantine centre of Jhalda P.S. During returning PS at Bandhagath under Jhalda PS area we found 03 (three) Motor cycles with three riders were plying making Halla, we intercepted them. But riders of Motor cycles fled away seeing Police party leaving 03 (three) Motor Cycles on road. We tried to apprehend them but failed. So, I seized those Motor cycles with proper seizure list.

Therefore, I pray a specific case may kindly be lodge against (i) Dayaram Mahato (21) S/O Lt.
