Nemo of Jhalda P.S. returned to PS with force and lodged this complaint against (i) Swapan Kalindi (19) S/O Madhurai Kalindi of Vill- Birudih, PS-Jhalda, Dist-Purulia (ii) Ramesh Kalindi (30) S/O Baura Kalindi of Vill- Birudih, PS-Jhalda, Dist-Purulia (iii) Madhab Mandal (19) S/O Aswini Mandal of Vill- Birudih, PS-Jhalda, Dist-Purulia (iv) Prafullya Mandal (22) S/O Chitta Mandal of Vill- Birudih, PS-Jhalda, Dist-Purulia (v) Kartik Gorat (28) S/O Rasaraj Gorat of Vill- Dibritikar, PS-Jhalda, Dist-Purulia (vi) Bhusan Gorat (30) S/O Tarun Gorat of Vill-Dibritikar, PS-Jhalda, Dist-Purulia (vii) Nabanidhar Mukherjee (48) S/O- Lt. Murulidhar Mukherjee of Vill-Khatjuri, PS-Jhalda, Dist-Purulia (viii) Gunudhar Mahali (35) S/O Ritu Mahali of Vill- Keruary (Tulin), PS- Jhalda, Dist- Purulia, (ix) Ashok Kumar Mahali (26) S/O Ritu Mahali of Vill- Keruary (Tulin), PS- Jhalda, Dist- Purulia to the effect that today i.e. on 21/04/2020 myself along with force C/571- Md. Hasib Khan, C/497- Ambuj Kr. Mandal, LC/1053- Pratima Choudhury, Hav/1644- Ashok Tamang, R/M-548 Rudramoni Pratap were engaged on Mobile duty. During Mobile duty as per direction we were engaged for implementation of Govt. rules regarding Lockdown and disaster management plan. During Mobile duty received information from on duty CVF at Jhalda BPHC that some persons of Jhalda PS area came from different working places to Jhalda BPHC for medical test. I informed the matter to I/C Jhalda PS and as per direction myself with force reached at Jhalda BPHC situated near Mosina more under Jhalda PS area at 17:45 hrs. and found above noted 09 persons waited for medical test. I examined them. During examination they disclosed their identity as noted above and admitted that violating Govt. order they came from their working places to their home crossing border of Jhalda PS. It was also known that they were working at different places of Jharkhand state like Ramgarh, Gola Chitarpur, Tata and Ranchi. During interrogation it is known that SL No- i) to iv) came from Ramgarh, Jharkhand, SL No- v) & vi) came from Gola Chitarpur, Jharkhand, SL No- vii) came from Ranchi, SL No- viii) & ix) came from Tata. In the view of pandemic disease COVID-19 Govt. promulgated Lockdown order and they were staying at their working places. Knowing all the direction of Govt. they came out from their working places and crossed border of Jhalda P.S. jurisdiction secretly and reached at Jhalda BPHC and disobeyed Govt. order and committed negligent act likely to spread infection of diseases dangerous to life and violated Quarantine rule. So, I arrested them maintaining all formalities of arrest and later on released on bail considering present situation of epidemic COVID-19. I also arranged for their medical test at Jhalda BPHC and as per advice of M.O. of Jhalda BPHC I kept them at KARMATHIRTHA, Institutional Quarantine centre of Jhalda P.S.

Therefore, I pray a specific case may kindly be started against (i) Swapan Kalindi (19) S/O Madhurai Kalindi of Vill- Birudih, PS-Jhalda, Dist-Purulia (ii) Ramesh Kalindi (30) S/O Baura Kalindi of Vill-Birudih, PS-Jhalda, Dist-Purulia (iii) Madhab Mandal (19) S/O Aswini Mandal of Vill- Birudih, PS-Jhalda, Dist-Purulia (v) Kartik Gorat (28) S/O Rasaraj Gorat of Vill- Dibritikar, PS-Jhalda, Dist-Purulia (vi) Bhusan Gorat (30) S/O Tarun Gorat of Vill- Dibritikar, PS-Jhalda, Dist-Purulia (vii) Nabanidhar Mukherjee (48) S/O- Lt. Murulidhar Mukherjee of Vill-Khatjuri, PS-Jhalda, Dist-Purulia (viii) Gunudhar Mahali (35) S/O Ritu Mahali of Vill-Keruary (Tulin), PS- Jhalda, Dist- Purulia, (ix) Ashok Kumar Mahali (26) S/O Ritu Mahali of Vill- Keruary (Tulin), PS- Jhalda, Dist- Purulia as they disobey Govt. order and committed negligent Act likely to spread infection of diseases dangerous to life and violated Quarantine rule U/S 188/269/270/271 IPC and 54 Disaster Management Act, 2005 and arrange for investigation.
