Sir,

I, SI Bikash Ch. Patra of Jhalda P.S. returned to PS with force and brought under seizure 1) one Red & white colour Hero Super Splendor Motor Cycle having No- WB56K 7067 2) one black colour Avenger 220 Motor Cycle having No- JH01DT 8166 and 3) one black colour Hero Super Splendor Motor Cycle having No- WB68V 8255 and lodged this complaint against 1) owner of Motor Cycle having No- WB56K 7067 2) owner of Motor Cycle having No- JH01DT 8166 and 3) owner of Motor Cycle having No- WB68V 8255 and others to the effect that today (23/04/2020) myself along with force C/571- Md. Hasib Khan, C/497- Ambuj Kr. Mandal was engaged in mobile duty. During Mobile duty as per direction we were engaged for implementation of Govt. rules regarding Lockdown and disaster management plan. At 17:45 Hrs. when myself with force reached at Birsha more under Jhalda P.S. We found 03 (three) Motor cycles with three riders in each Motor cycles were plying in excessive speed, making Halla. We tried to intercept them. But riders of Motor cycles fled away seeing Police party leaving 03 (three) Motor Cycles on road. We tried to apprehend them but failed. So, there is every reason to believe that the riders of those 03 (Three) Motorcycles came out from their home and moving aimlessly or making fun. Though lockdown is going on throughout the District of Purulia in view of Pandemic of COIVD-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- H & F W/120/20 dated 22.03.2020 which is extended till 03.05.2020. Therefore they disobeyed Govt. order and committed negligent act likely to spread infection of diseases dangerous to life and violated Quarantine rule. So, I seized those Motor cycles with proper seizure list.

Therefore, I pray a specific case may kindly be lodge against 1) owner of Motor Cycle having No- WB56K 7067 2) owner of Motor Cycle having No- JH01DT 8166 and 3) owner of Motor Cycle having No- WB68V 8255 and others as they disobey Govt. order and committed negligent Act likely to spread infection of diseases dangerous to lie and violated Quarantine rule U/S 188/269/270/271/279 IPC and 54 Disaster Management Act, 2005 and arrange for investigation.
