Sir,

I, SI Bikash Ch. Patra of Jhalda P.S. returned to PS with force and brought under seizure 1) One black and white colour Hero Super Splendor Motor Cycle without number plate having engine No- JA06EHJ9D00796, Chassis No- MBLJAR160J9D03384 2) One black and yellow colour Yamaha Motor Cycle having No- WB56M 2402 and lodged this complaint against 1) Bishnu Rajak (32) S/O Angad Rajak of Jhalda Station Para, Ward No- 12, PS- Jhalda, Dist- Purulia, owner of Motor Cycle without number plate having engine No- JA06EHJ9D00796, Chassis No- MBLJAR160J9D03384 2) Muruli Mahato (50) S/O Lt. Matharam Mahato of Vill- Mosina, PS- Jhalda, Dist- Purulia 3) Sachi Mahato (40) S/O Lt. Srikanta Mahato of Vill- Gokulnagar, PS- Jhalda, Dist- Purulia 4) Owner of Motor Cycle having No- WB56M 2402 and others to the effect that today (24/04/2020) myself along with force C/611- Jjitendranath Pathak, NVF/039- Lalit Kishore Mahato, Dy.G.C/93- Jogen Sing Mura, R/M- 1517- Tufan Pradhan was engaged in mobile duty. During Mobile duty as per direction we were engaged for implementation of Govt. rules regarding Lockdown and disaster management plan. At 15:45 Hrs. when myself with force reached at Bandhaghat under Jhalda P.S. we found 02 (two) Motor cycles with three riders in each Motor cycles were plying in excessive speed, making Halla. We tried to intercept them. But seeing Police party all started to flee away. We chased and managed to apprehend 03 (three) persons as noted above but rest fled away. I examined them and during examination they disclosed their identity as noted above but they did not give proper reason why they came out from house and reached there. During examination it is also known that Sl. No- 1) is the owner of the Motor Cycle without number plate having engine No- JA06EHJ9D00796, Chassis No- MBLJAR160J9D03384 and Sl. No. 2) & 3) are pillion riders but they could not produce any documents related to this Motorcycle. So, there is every reason to believe that the riders of those 02 (Two) Motorcycles came out from their home and moving aimlessly or making fun. Though lockdown is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- H & F W/120/20 dated 22.03.2020 which is extended till 03.05.2020. Therefore they disobeyed Govt. order and committed negligent act likely to spread infection of diseases dangerous to life and violated Quarantine rule. So, I seized those Motor cycles with proper seizure list. I also arrested above noted accd. persons maintaining all formalities of arrest and later on released on bail considering present situation of epidemic COVID-19.

Therefore, I pray a specific case may kindly be lodge against 1) Bishnu Rajak (32) S/O Angad Rajak of Jhalda Station Para, Ward No- 12, PS- Jhalda, Dist- Purulia, owner of Motor Cycle without number plate having engine No- JA06EHJ9D00796, Chassis No- MBLJAR160J9D03384 2) Muruli Mahato (50) S/O Lt. Matharam Mahato of Vill- Mosina, PS- Jhalda, Dist- Purulia 3) Sachi Mahato (40) S/O Lt. Srikanta Mahato of Vill- Gokulnagar, PS- Jhalda, Dist- Purulia 4) Owner of Motor Cycle having No- WB56M 2402 and others as they disobey Govt. order and committed negligent Act likely to spread infection of diseases dangerous to life and violated Quarantine rule U/S 188/269/270/271/279 IPC and 51 Disaster Management Act, 2005 and arrange for investigation.
