

1, SI Hemanta Kr. Sahababu of Jhalda P.S. returned to PS with force and brought under seizure 1) One red colour Honda Levo Het Motor Cycle having No-JH01CF 5671 2) One red colour Toto without regd. no 3) One Orange colour Toto without regd, no and lodged this complaint against 1) Shyamapada Kumar (22) \$/0 Paresh Ch. Kumar of Vill- Pusti, PS- Jhalda, Dist- Purulia 2) Deshbandhu Mahato (25) S/O Nagendranath Mahato of Do 3) Krishna Gopal Bal (28) S/O Lt. Ujjal Bal of Vill- Nirol, PS- Ketugram, Dist- Purba Bardhaman 4) Niranjan Kumar (24) S/O Gopal Kumar of Vill- Beladih, PS- Kotshila, Dist- Purulia 5) Dinabandhu Kumar (25) S/O Mansaram Kumar of Do 6) Uttaran Gorain (20) S/O Bhirgu Gorain of Do 7) Sk. Hamid Reja (26) S/O Sk. Yaub of Vill- Kantadih, PS- Jhalda, Dist- Purulia and 8) Nayaj Kaji (24) S/O Sukur Kaji of Do to the effect that today (26/04/2020) myself along with force C/386-Sibendu Sinha, C/1179- Pabitra Mandal was engaged in Spl. mobile duty. During Spl. Mobile duty as per direction we were engaged for implementation of Govt. rules regarding Lockdown and disaster management plan. At 18:45 Hrs. when myself with force was performing Naka checking at Jhalda Bus stand under Jhalda P.S. above noted Motor cycle with three riders and Toto's with passengers were detained as they were moving aimlessly and creating Halla. I examined them and during examination they disclosed their identity as noted above but they did not give proper reason why they came out from house and reached there. It is known that Sl. No- 1) to 3) was riding in the Motor Cycle, Sl. No. 7) & 8) are owners of Totos and Sl. No 4) to 6) are passengers of Totos. They could not produce any documents related to this Motorcycle and Totos. So, there is every reason to believe that the riders of those Motorcycle and passengers and owners of Totos came out from their home and moving aimlessly or making fun and they did not came for emergency purpose. Though lockdown is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- H & F W/120/20 dated 22.03.2020 which is extended till 03.05.2020. Therefore they disobeyed Govt. order and committed negligent act likely to spread infection of diseases dangerous to life and violated Quarantine rule. So, I seized those Motor cycle and Totos with proper seizure list. I also arrested above noted accd. persons maintaining all formalities of arrest and later on released on bail considering present situation of epidemic COVID-19, St. No. 3) has been send to Karmatirtha, institute Quarantine of Jhalda P.S. after Medical checkup as per advice of M.O.

Therefore, I pray a specific case may kindly be lodge against 1) Shyamapada Kumar (22) \$/O Paresh Ch.
