Sub: Request for lodging F.I.R. against arrested accused Chandicharan Tewari & Thakurlal Kumar.

Sir,

With due respect I SI Susanta Kr Pathak of Joypur PS, beg to submit before you that on 26/04/2020 at about 07:15 hrs while myself along with force were performing mobile duty vide Joypur PS C.C No-1702/20 Date-26/04/2020 and found the following persons with their Motor Cycles noted against each, were roaming aimlessly at bazaar area, Police party detained them at Joypur near Hospital More on Purulia-Ranchi- pitch road under Joypur PS. On being asked the following persons could not able to give any satisfactory answer for that movement on road and public place. Though lockdown is going on throughout the District of Purulia in view of Pandemic of COIVD-19 outbreak, Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020. As such the following persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No-11 & F W/120/20 dated 22.03.2020 which is extended till 03.05.2020. Moreover all the detained persons were refuses to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic. All the accused persons also tried negligently to spar spared infection of disease dangerous to life. Accordingly the following persons were arrested and seized 02 motor cycles from 07:35 Hrs. to 07:45 hrs. under proper seizure list duly signed by the witnesses and the accused persons, after maintaining all formalities regarding arrest and seizure & prepared arrest memos and brought them to P.S

1. Chandicharan Tewari (32 yrs) S/o-Late Girish Ch Tewari of Vill-Ichag (Meshya), PS-Jhalda, Dist-Purulia, (Motor Cycle No-JH109U-1812).
2. Thakurlal Kumar (21 yrs) S/o-Bhabatosh Kumar of Vill-Barabendya, PS-Joypur, Dist-Purulia (Motor Cycle No-JH10AQ-9275).

Hence it is prayed before you that above mentioned persons may kindly be prosecuted U/S 188/269/270/34 IPC & Read with section 51 of Pandemic Disaster Management Act, 2005.
