Sir,

In producing herewith one arrested accused person namely Ramdas Bagti (40 yrs) S/o-Late Paban Bagti of Vill-Joypur Bagtipara, PS- Joypur Dist- Purulia, State-WB under arrest along with seized articles as per seizer list i.e. 10 (Ten) Liter ID liquor (Mohula) under proper seizure with label,

I ASI Jagannath Rakshit of Joypur PS hereby lodged a written complaint against the above noted arrested accused person to the effect that on today (26/04/2020) at about 18:45 hrs when myself along with JC/-578 Asish Rout, JC/-426 Biswajit Banik were performing special mobile duty, as per my source information I reached at Joypur Bagtipara under Joypur PS and found that the above noted accused person selling Id liquor (Mohula) in his house. On seeing Police persons, he conceal his presence at that house, but on searching we able to trace out him and also to found that 10 (ten) liter of Illicit Liquor which was kept conceal at his house. On being asked he disclosed his name and address as noted above. On interrogation he stated that he was selling Illicit country spirit liquor to the local people in his house at Joypur Bagtipara. On demand he failed to produce any valid documents in respect of selling such illicit liquor. So it is reasonable to believe that he was selling the Id liquor illegally without any documents. So I seized the same under proper seizure list in between 19:05 hrs to 19:15 hrs & label duly signed by him and other available witness after taking 300 ML as sample in a separate bottle from the Jarican.

During further interrogation he confessed his guilt as such I arrested him today 26/04/2020 at 19:35 hrs as the accused person is liable for prosecution u/s-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific case may kindly be started against the accused person namely Ramdas Bagti (40 yrs) S/o-Late Paban Bagti of Vill-Joypur Bagtipara, PS- Joypur Dist- Purulia, State-WB U/S-46A (c) of the Bengal Excise Act 1909.
