**Sub:** Request for lodging F.I.R. against arrested accused Debilal Saren & 04 others.

Sir,

In producing here with 05 (Five) arrested accused namely 1.Debilal Soren(52), s/o-Lt Surendranath Saren of vill-Shyampur, 2)Goutam Roy(23), s/o Dipak Roy of vill-Liya,3) Nimai Bauri,(48) s/o-Lt Kinkar Bauri,vill-Kalloli,4)Gagan Bauri,(47) s/o-Lt Sarat Bauri, 5) Sitaram Bauri(55), s/o-Lt Gobinda Bauri of vill-Kalloli, all of PS-Kashipur, Dist- Purulia along with Memo of Arrest.

I SI Dharanidhar Pandey of Kashipur PS do here by lodged a complaint against above noted 05 accused persons to the effect that on 25.04.2020 at about 16:25 hrs while I was on patrolling duty, found 10-12 persons consisting of their 03-04 Motorcycle gathered at BL & LRO office more, Talajuri-Kashipur Main Road . After seeing the police party 06-07 persons consist of their respective 03-04 Motorcycle fled away. Rest persons also tried to flee away but after reaching the spot we managed to detain 05 persons. On being asked the following persons could not be able to give any satisfactory answer for that gathering on the road or they could not be able to give reasonable ground for this gathering. As such the above persons violated the order during this pandemic situation duly promulgated by Ministry of Home Affairs, Govt. of India, vide Order No- 40-3/2020-DM-I (A) dated- 15<sup>th</sup> April, 2020 to 3<sup>rd</sup> May 2020. Accordingly the following 05 (Five) persons were arrested from 16.35 to 17.15 Hrs. after maintaining all formalities regarding arrest and brought them to P.S. I offered them for medical treatment but they denied.

Hence I therefore pray that a specific case may kindly be started against above mentioned persons U/S-188/34 IPC & Section 51 (1) (b) in the National Disaster Management Act, 2005.
