


Respected Sir,

In producing here with Three arrested accused persons namely 1) Bidhan Mahato (23) Bhutnath Mahato 2) Ashutosh Mahato (22) S/O Sahadeb Mahato both of village- Jabla P.S Manbazar Dist- Purulia 3) Sanjoy Mahato (24) S/O Sunil Mahato of village Penchara P.S Kenda dist- Purulia to the effect that today (25/04/2020) at about 16:35 hrs, while I, SI Bapan Mondal S/O Ashoke Kumar Mondal of Vill - Jhaukhali P.S - Bagdah Dist- North 24 PGS at present posted at Kenda P.S as S.I Of Police along with force were performing mobile duty received secrete source information that a cock fight (Murga Larai) Programme held at Kurmasole village at Thanthani Field and gathered approx 25/30 persons at the Spot which is noted in Kenda PS GDE No-722, Dt-25.04.2020 . I informed the fact to O/C Kenda PS and as per his direction , myself along with force had been to Thanthani Field of K Kurmasole village to work out the information. After reaching their at 17:20 hrs. and found that approx 25/30 persons has been gathered .Seeing the Police all the persons fled away from the spot and we able to arrest above noted 03 (Three) accused persons . During enquiry it could learnt that the following persons namely 1) Sunil Mahato S/O Chhutulal Mahato 2) Kharu Majhi S/O Padak Majhi 3) Prabir Mahato S/O Lt. Satyaban Mahato all of village Kuda P.S Kenda Dist- Purulia 4) Sanjoy Mahato S/O Amarnath Mahato 5) Abdul Ansary S/O Jhar Ansary 6) Jhar Ansary S/O Misrali Ansary 7) Sunil Gorain S/O Muruli Gorain 8) Paban Mahato S/O Dhruvaraj Mahato 9) Brihaspati Mahato S/O Chhutulala Mahato 10) Bikash Mahato S/O Deben Mahato 11) Dipendu Mahato S/O Amulya Mahato 12) Adrista Mahato S/O Sripati Mahato 13) Rabi Sing S/O Sundar Sing 14) Kharu Mahato S/O Lt. On being asked the arrested accused persons could not able to give any satisfactory answer for their presence at the spot at that time . Though lockdown is going on throughout the district of Purulia in view of Pandemic of COVID - 19 outbreak, vide Govt. of India consolidated order No. 40-3/2020-DM-I (A) Date - 24/03/2020 and further modified order dated - 25/03/2020 , 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No. H & F W/120/20 dated 22.03.2020 which is extended till 03.05.2020. Moreover, all the above noted detained persons and others persons who were present at the cock fight spot were refused to comply the direction given by the Central Govt. & State Govt. to combat the rapidity of pandemic COVID - 19. All the accused persons also tried negligently to spread infection of disease which dangerous to human life.

Hence I pray that kindly treat this as FIR as per law and arrange for its investigation.
