SI Bapan Mondal S/O Ashoke Kumar Mondal of Vill - Ihaukhali P.S - Bagdah Dist- North 24 PGS as SI of Police at Kenda police station Dist- Purulia do hereby lodge complaint as suo-moto against the below noted accuse persons to the effect that On (26.04.2020) I accompanied with available officers and forces vide Kenda P.S CC NO - 361/2020, 362/2020, 363/2020 and Dtd- 26.04.2020 as per your order had been to village Jambaid by Govt. Vehicle vide vehicle reg. No- WB-56C- 0019, & WB-42S - 1504 for enquiry the violation of lockdown regulation which is noted in Kenda P.S GDE No- 760 dtd- 26.04.2020 i.e approx 200 people has been gathered at Jambaid Shib Mandir to celebrate "Shib Gajan". While we reached on 26.04.2020 at about 17:05 hrs at Jambaid Shib Mandir and found that approx 200 people has been gathered at Jambaid Shib Mandir to celebrate "Shib Gajan". When I want to talk with the Shib Gajan committee members, Some of the persons was throwing Stone & Bricks due to miss understanding. They thought that Police has came to the spot to stop their Shib Gajan celebration.

During enquiry it could learnt that the following persons namely 1) Parimal Mahato S/O Pravakar Mahato 2) Arup Mukherjee S/O Haru Mukharjee 3) Ujjal Mukherjee S/O Haru Mukherjee 4) Bholanath Mukharjee S/O Gurupada Mukherjee 5) Lakhan Paramanik S/O Iswar Paramanik 6) Rajesh Jogi S/O Khudiram Jogi 7) Lokesh Rajwar S/O Jyoti Rajwar 8) Bulet Majhi S/O Badyanath Majhi 9) Mathan Mahato S/O Golok Mahato 10) Bhairab Mahato S/O Badyanath Mahato 11) Uttam Mahato S/O Lalit Mahato 12) Subhash Mahato S/O Lalu Mahato 13) Bhaktaranjan Sarkar S/O Lt. On being asked the committee could not able to give any satisfactory answer for the celebration of Sib Gajan during the time of lockdown period. Though lockdown is going on throughout the district of Purulia in view of Pandemic of COVID - 19 outbreak, vide Govt. of India consolidated order No. 40-3/2020-DM-1 (A) Date - 24/03/2020 and further modified order dated - 25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation, duly promulgated by Govt. of West Bengal vide Order No. H & F W/120/20 dated 22.03.2020 which is extended till 03.05.2020. Moreover, all the above noted persons who were present at the "Shib Gajan" celebration spot were refused to comply the direction given by the Central Govt. & State Govt. to combat the rapidity of pandemic COVID - 19. All the accused persons also tried negligently to spread infection of disease which dangerous to human life.

Hence I pray that kindly treat this as FIR as per law and arrange for its investigation.
