I SI Indrajit Sarkar of Manbazar PS do hereby lodged a complaint against 1) Sandip Malakar (25) S/O Ashok Malakar of village Manbazar Malakarpara, PS Manbazar, District Purulia 2) Pradip Malakar (28) S/O LA Nityamanda Malakar of village Manbazar Malakarpara, PS Manbazar, District Purulia that today on 01.04.20 at about 18.00 hrs I have got an information from an unknown caller that above persons posted in Bengali version " Chhi, Chhi, Chhi, Chhi, Dhikkar Jamil Manbazar Prasasanke Ei Rakam Jaghanya Padakshyep niye, Manbazarer Sadharan Manuske Bipader Mukhe Thele Decoyar Janya.... Apnara Janen Bhin Rajya O Bivinya Desh Theke kichu Jubak din 7-8 age Manbazar sabarer ashe - pashe bivinya gramte ese upasहित boyochhila Ar aj sei samasta jubakder madhye kichhu jubake, jader sarite " Corona virus er" mitto maran byadhi roger upasarga rayeche taderke Manbazar prasasan "Krishan Mandir" Mato a gurutto purna jaygay kosorakam Isolation word chharai ki kore rakha sambhab... ? Jekhane pratidin hajaro sankhak manush k tader nityaprayojaniya jinish kena- kata karte atehoy. Tahale ki ei samasta sadharan manush o Manbazar busike jene bujhe bipader mukhe phele decoy noy ? Amra jani Corona virus kazota marattak khotitikanak. Tai akhara samoy ache oi post ke samasta Manbazar Basir kachhe pouche din ebong ek pratibad gare tulan asus amra sobai mile amader Manbazar, amader Purulia, Amader West Bengal o amader Bharatbarsha ke Corona mukta Kore tui "Stay home, Stay safe" in different whats app groups and facebook page Malignantly, which is illegal and gives provocation to any person intending of knowing it to be likely that such provocation will cause the offence of Rioting be committed in consequence of such provocation. They also disobeyed the Govt. order regarding recent pandemic situation for attack of Corona Virus throughout India as well as whole World. Thus insulted the common people intentionally and there by gives provocation to break the public peace or commit any other offence throughout the society fully neglecting the Govt. order. They also spread rumors in this disaster situation which effects social life and it defames the image of Manbazar Block Administration.


Accordingly I go through the Whatsapp group and facebook page of them taking help of witnesses and verified the complaint and found it to be authenticated. Then I took screen shot of those pages and also made printout of those pages which are attached with this complaint.

As the above persons have committed the offence punishable U/S 188/153/500/504/120B IPC & Sec 54 of National Disaster Management Act 2005. I request for starting a case and also arrange for its investigation.
