Sub: Prayer for starting a specific case under proper section of law.

Sir,

In producing herewith one seized vehicle (Pick – up, Ashok Leyland Ltd.) bearing no – JH 10BF/9488 loaded with raw coal of 01 M.T. (approx) I, ASI Sk. Monsur, do hereby lodge a complaint to the effect that on (13/04/2020) I along with C/1140 Dayamoy Mahato, C/1260 Santosh Saren and C/480 Uttam Bouri all of Neturia PS were engaged in Naka duty at Dishergarh Ghat vide Neturia PS GDE No- 519 Dt. 13.04.2020 & CC No- 1063/2020 Dt. 13.04.2020 in c/w Covid-19. In course of Naka duty at about 20:05 hrs found some vehicles are coming from Asansol side. Accordingly we started searching the vehicle one by one and found one vehicle (Pick – up, Ashok Leyland Ltd.) bearing no – JH 10BF/9488 but the driver was not present in the cabin. We searched the surrounding area with torch light to find out the driver but failed to trace out him. On search we found that the vehicle (Pick – up, Ashok Leyland Ltd.) bearing no – JH 10BF/9488 loaded with raw coal of 01 M.T. (approx) and covered with the tray of fruit basket and the key of the vehicle has been left away in the vehicle by the driver. I immediately intimated to you over phone regarding this matter and as per your kind direction I seized the vehicle (Pick – up, Ashok Leyland Ltd.) bearing no – JH 10BF/9488 loaded with raw coal of 01 M.T. (approx) under proper seizure list duly signed by the Police witnesses in between 21:15 hrs and 21:35 hrs, since no public witness was found.

There is reason to believe that the driver, owner of coal and registered owner of the vehicle have collected the said coal either by theft or by any fraudulent means and after hatching a criminal conspiracy, they are trying to dispose of the same coal in a clandestine manner to Raghunathpur side knowing it to be stolen, as per their regular practice.

Under the above circumstances a specific case may kindly be started against the (1) driver of above noted vehicle (2) owner of the coal, seized from vehicle and (3) Registered owner of vehicle under proper section of law.
