Sub: Complain to start a specific case.

Sir,

In producing herewith 03(Three) arrested accused persons namely (1) Sk. Samim (30) S/O- Sk. Badruddin (2) Sk. Muslim (36) S/O- Abdul Khaled both of Gorabari, PS- Neturia, Dist- Purulia and (3) Sk. Samsar Ali (22) S/O- Sk. Farid of Heddi (Gorabari), PS- Neturia, Dist- Purulia with seized one Hero Glamour Motor Cycle bearing registration No- WB-82B/3307 having Engine No- JA06ERHGD39275 and Chassis No- MBLJAR027HGD31218. I beg to submit that during mobile duty as per direction we were engaged for implementation of Govt. rules regarding lock down Disaster Management plan. At about 11:35 hrs today on 26.04.2020 when I along with force reached at Nimdanga Morh (Sarbari-Panchet Road) under Neturia PS and found that 01 (One) motor cycle with 01(One) rider along with 02 (two) pillion riders in his Motor Cycle was plying from Sarbari side and making Halla on road. I intercepted them and also apprehended and on being asked the above noted persons could not able to give any satisfactory answer for their movement on road and public place. So there is every reason to believe that the above noted 03 (Three) accused persons came out from their home and moving aimlessly or making fun. Though lockdown is going on throughout the District of Purulia as well as in the state in view of Pandemic of COVID-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- H & F W/120/20 dated 22.03.2020 which is extended till 03.05.2020. Therefore they disobeyed Govt. order and committed negligent act likely to spread infection of diseases dangerous to life and violated Quarantine rule. So, I arrested the above noted 03 (Three) accused persons. During the time of arrest maintained all formalities regarding arrest and seized the Motor cycle with proper seizure list duly signed by the police witnesses as no public witnesses appeared to put sign. After arrest they were medically checked up at Harmadiah CHC.

Therefore, I pray a specific case may kindly be started against 03(Three) arrested accused persons namely (1) Sk. Samim (30) S/O- Sk. Badruddin (2) Sk. Muslim (36) S/O- Abdul Khaled both of Gorabari, PS- Neturia, Dist- Purulia and (3) Sk. Samsar Ali (22) S/O- Sk. Farid of Heddi (Gorabari), PS- Neturia, Dist- Purulia and owner of the motorcycle bearing Registration No. WB-82B/3307 having Engine No- JA06ERHGD39275 and Chassis No- MBLJAR027HGD31218 as they disobeyed Govt. order and committed negligent Act likely to spread infection of diseases dangerous to life and violated Quarantine rule U/S- 188/34 IPC and 51 Disaster Management Act, 2005 and arrange for investigation.
