I would like to note here that today at 10: 25 hrs I received a telephonic information from Hariharpur Village under Para PS that a tension was going on there over the issue of selling vegetable. Accordingly I diarised the matter Vide Para PS GDE No. 904 dtd. 21.04.2020 and myself along with SI Uttam Kr. Mandal, SI Parimal Ghosh, ASI Santosh Roy, ASI Tapas Panda, C/ 1016 Mantu Murmu and C/699 Biswajit Banerjee to look into the matter vide Para PS GDE NO. 905 and C.C. No.

We reached at Hariharpur village at 10: 45 hrs and found that 100/150 persons of Basak Para and about 100/120 persons of Darji Para were pelting stones aiming at each others. Basak Para and Darji Para are attached to each other near Bara Masjid. The persons in the both sides were equipped with lathi tangi iron rod swords etc. We shouted them to stop but they did not pay any attention and started pelting stones to us and as a result SI Uttam Mandal , SI Parimal Ghosh, C/1016 Mantu Murmu and C/699 Biswajit Banerjee got injury later on they treated at Para BPHC. Our strength was weak in comparison with their number and so we took shelter near Bara Masjid . I rang for reinforcement as we had not adequate strength

so we had no option but for waiting for reinforcement. Later on at 11:35 hrs additional force reached there and we chased the mob . We after hot chase managed to arrest twelve persons who revealed their identities as 1) Sk Alamgir (32) S/o Sk rouf of Hariharpur, 2) Kheyajuddin Darjee (27) S/o Monbhul Darjee of Hariharpur, 3) Sk Siraj (40) S/o Asadulla of Hariharpur, 4) Sk Amir Hossain (42) S/o Lt- Khelafat Sk of Sankra "B", 5) Sk Ramjan (35) S/o Sk Basir of Sankra "B", 6) Seker Ali (21) S/o Ajahar of Hariharpur, 7) SK Rahaman (40) S/o Lt- Rahim of Hariharpur, 8) Jalal Sk (34) S/o Lt- Karim Sk of Hariharpur, 9)Safikul Islam (19) S/o Sariful Islam of Sankra "B", 10) Sk Yasin (22) S/o Eklak Hossain of Sankra "B", 11)Sk Samad (45) S/o Lt- Hanif of Sankra "B", 12) Sk Gaffar (42) S/o Lt- Sk Julmat of Sankra "B", all of PS- Para, Dist- Purulia while the others managed to escape. I would like to note here that 1) Sk Alamgir (32) S/o Sk Rouf of Hariharpur, 2) Kheyajuddin Darjee (27) S/o Monbhul Darjee of Hariharpur were found having injuries on their persons which they got during the rioting. We arranged for their treatment at Para BPHC. Also due to this incident it was learnt that one Manwar Sk S/o Sk Rouf of village- Hariharpur got serious injury and shifted him any hospital by themselves.

I seized ten brick bats, four bamboo sticks and five stones from the PO. From the arrested accd persons as well as from local enquiry the involvement of above noted accused persons was found in this case . During local enquiry it was learnt that today Yunish Darjee of Darjee Para went to the vegetable shop of Sk Alamgir of Basak Para . A hot altercation started between them . They started scuffling . Within a moment the neighbours of Basak Para stood by Sk Alamgir and accordingly the people of Darjee Para took side of Yunish Darjee and it led a serious rioting . Had we not interfere in time ¾ persons from both the sides could have been died .

It is also to be noted that during lock down process they violated the order during this pandemic situation duly promulgated by Ministry of Home Affairs, Govt. of India, vide Order No- 40-3/2020-DM-I (A) dated- 15th April, 2020 to 3rd May 2020.

Hence they have committed the offenses come under the ambit of U/S 147/148/149/186/188/353/332/333/323/325/308 IPC and Section 54 in the National Disaster Management Act, 2005 & 32 Police Act.

Hence I do start Para PS case No 34/20 Dtd 21.4.2020 U/S 147/148/149/186/188/353/332/333/325/308 IPC and Section 54 in the National Disaster Management Act, 2005 & 32 Police Act. and endorsed SI Dipak Nandi to investigate the case.
