Sir,

In producing here with 04(Four) arrested accused persons namely 1) Md. Salim (25yrs) S/o Jamal Ahamed of Dubra, PS- Para, Dist- Purulia 2) Rajib Mahato (23yrs) S/o Anil Mahato of Bhalpahari, Santaldih, Dist- Purulia 3) Ajay Rajwar (18yrs) S/o Jimu Rajwar of Bhalkhhuria, PS- Para, Dist- Purulia 4) Md. Nair Alam (20yrs) S/o Md. Samim Alam of Dubra, PS- Para, Dist- Purulia and owner of Motor Cycle bearing registration no. WB-82B/8897 and Blue colour new Motor Cycle (Hero Glamour) bearing engine JAQ6ERJ GG28237 and chassis no. MBIJAR020JGG19930.

I, SI Dipak Nandi of Para PS returned to PS with above noted 04(Four) arrested accused persons and brought under seizure above noted 02(Two) Motor Cycles to the effect that today (24.04.2020) myself along with force were engaged in mobile duty. During mobile duty as per direction we were engaged for implementation of Govt. rules regarding lock down Disaster Management plan. At 15.05 hrs when they reached at Dubra bazaar near Durga Mandir under Para PS and found that 02(Two) motor cycles with 02(Two) riders with 04 (four) pillion riders in their Motor Cycles were plying in excessive speed, making halla. They tried to intercept them and also apprehend them and finally they able to arrest the above noted 02(Two) riders and 02(Two) Pillion riders but 01(One) pillion riders of each Motor Cycle fled away seeing police party. So there is every reason to believe that the riders of 02(Two) Motor Cycles with 04 (four) pillion riders came out from their home and moving aimlessly or making fun. Though lockdown is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- H & F W/120/20 dated 22.03.2020 which is extended till 03.05.2020. Therefore they disobeyed Govt. order and committed negligent act likely to spread infection of diseases dangerous to life and violated Quarantine rule. So, I arrested the above noted 04(Four) accused persons and seized those Motor cycles with proper seizure list.

Therefore, I pray a specific case may kindly be lodge against 1) Md. Salim (25yrs) S/o Jamal Ahamed of Dubra, PS- Para, Dist- Purulia 2) Rajeeb Mahato (23yrs) S/o Anil Mahato of Bhalpahari, Santaldih, Dist- Purulia 3) Ajay Rajwar (18yrs) S/o Jimu Rajwar of Bhalkhhuria, PS- Para, Dist- Purulia 4) Md. Nair Alam (20yrs) S/o Md. Samim Alam of Dubra, PS- Para, Dist- Purulia and owner of motor cycle bearing registration no. WB-82B/8897 and Blue colour new motor cycle (Hero Glamour) bearing engine No. JAQ6ERJ GG28237 and chassis no. MBIJAR020JGG19930 as they disobeyed Govt. order and committed negligent Act likely to spread infection of diseases dangerous to lie and violated Quarantine rule U/S 188/34 IPC and 51/54 Disaster Management Act, 2005 and arrange for investigation.
