Sir,

In producing herewith the following 17 numbers of persons along with 08 motorcycles along with memo of arrest issued against each and the 08 numbers seizure list before you. The fact of the case in a nut shell is that I SI Purnendu Dutta along with force namely 1) C/39 Jaharlal Sannal 2) C/416 Sahadeb Hansda 3) C/1187 Samar Maity 4) JC/783 Susanta Panda was performing the mobile duty vide Purulia (M) PS GDE No 1138 dated 29.04.2020 in consonance with C.C No 1218 dated 29.4.2020. Subsequently, as per your instruction I along with force performed the Naka Checking at Chharah Xing on Purulia Barakar Road SH-5 from 11:15 hrs. and onwards and intercepted following persons and asked them regarding the reason of their circumambulation on the road without maintaining the social distance to each other, some of them riding motor cycles with one or two pillion rider during the time of pandemic situation. On being asked they could not give sufficient reason or satisfactory answer of their circumambulation on road. Consequently, it reasoned to believe that they violated the order and disobeyed the direction during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No. 11 & FW/120/20 dated 22.03.2020 which is extended till 03.05.2020. Subsequently it is pertinent to say that the following persons did the negligent act knowing themselves that their malignant act were likely to spread infection of the epidemic diseases which is dangerous to life themselves and others. Consequently, the following persons were arrested on the spot and informed them the ground of their arrest and issued memo of arrest in respect of them and seized their respective Motor Cycles listed in the below after preparing the proper seizure list duly signed by them.
