Sir,

I SI Ramu Gurung, of Purulia (T) PS do hereby lodged complaint against Udaygiri Acharya (30 yrs) s/o Birinchi Acharya of Reni Road, Jamuna Bandh Para, Ward No- 21, PS-Purulia (T), Dist- Purulia and others, that today (10.04.2020) at about 15:45 hrs I have received an information from an unknown caller that the above person posted "মমতা ব্যনার্জির মুসলিম তুষ্টি করন রাজনীতির জন্য হিন্দু সমাজ আতঙ্কিত পুলিশ মন্ত্রী ধরছেন আলিমুদ্দিন ফেরত ফিদায়ী করোনা জিহাদিদের" in Facebook page malignantly, which is illegal and gives provocation to any person intending of knowing it to be likely that such provocation will cause the offence of rioting be committed in consequence of such provocation. They also disobeyed the Government Order regarding recent pandemic situation for attacking of Corona virus throughout the India as well as whole World. Thus insulted the common people intentionally and circulated false information among the people through social media (Facebook) and thereby gives provocation to break the public peace and having conspired with others facebook sharers tried to commit communal riot in the society or to commit any other offence throughout the society fully neglecting the Govt. order during this pandemic situation.

Accordingly I go through the Facebook page of him taking help of witnesses and verified the complaint and found it to be authenticated. Then I took screen shot of those pages and also made print out of those pages which are attached with this complaint.

As the above person has committed the offence punishable U/S 188/203/153/504/120B IPC. & Sec 54 of National Disaster Management Act. 2005.

So I request for starting a case and also arrange for its investigation.
