Sir,

With due respect I ASI Tapas Patra, beg to submit before you that on 10.04.2020 at about 16:05 Hrs while under signed was on area round duty, found following persons with their Motor Cycles noted against each, were gathered at Rathala Morh under Purulia (I) PS and detained at the spot. On being asked the following persons could not able to give any satisfactory answer for that gathering on the road. As such the following persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- H & F W/120/20 dated 22.03.2020 which is extended till 14.04.2020. Moreover all the detained persons were making and circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people and as well as the society. Accordingly the following persons were arrested and seized 02 motor cycles from 17:15 Hrs. to 19:45 Hrs. after maintaining all formalities regarding arrest and seizure and brought them to P.S
