Sir,

With due respect I SI Ramu Gurung, beg to submit before you that on 18.04.2020 at about 10:20 Hrs while under signed was on area round duty, found following 08 (eight) arrested persons, Karabi Sarkar(Ghosh) w/o-Robin Ghosh of Munsifdanga, PS- Purulia (I), Dist- Purulia & others unknown CPIM supporters, were organizing a procession from Gosala morh, Purulia to Garikhana, on Barakar Road under Purulia town PS area with party flag and posters attached to their shirts without any permission even they did not maintain social distance and as well as to break the lock down system. As per Govt. circular, the political programme irrespective of all political parties is restricted in this pandemic situation. They detained at Goshala morh, near Rajasthan Vidyapith. On being asked the following persons could not able to give any satisfactory answer for that gathering on the road. As such the following persons violated the order during this pandemic situation duly promulgated by Ministry of Home Affairs, Govt. of India, vide Order No- 40-3/2020-DM-I (A) dated- 15th April, 2020 to 3rd May 2020. Moreover all the persons were making and circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people and as well as the society and give provocation to the people to break public peace or to commit other offence making conspiracy. They also disobeyed the Government Order regarding recent pandemic situation for attacking of Corona virus throughout the India as well as whole World. Accordingly the following persons were arrested from 10:45 Hrs. to 11:20 Hrs. after maintaining all formalities regarding arrest and brought them to P.S
