Sub: Request for lodging F.I.R. against arrested accused Suraj Bauri & 12 others.

Sir,

With due respect I, SI Subrata Sarkar, beg to submit before you that on 25.04.2020 at about 17:25 Hrs while under signed was on area round duty, found following persons with their Motor Cycles noted against each, were gathered at Victoria Mohr under Purulia (I) PS and detained at the spot. On being asked the following persons could not able to give any satisfactory answer for that gathering on the road. As such the following persons violated the order during this pandemic situation duly promulgated by Ministry of Home Affairs, Govt. of India, vide Order No- 40-3/2020 DM-1 (A) dated- 15th April, 2020 to 3rd May 2020. Moreover all the detained persons were making and circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people and as well as the society. Accordingly the following persons were arrested and seized 02 two-wheelers (1) Yamaha FZ-5 Motor Cycle having Reg. No- WB56P 0715, (2) Yamaha R-15 Motor Cycle having Reg. No- WB56Q 0154, and 01- four-wheeler Ford Figo having Reg. No- WB04H 0343 from 18:05 Hrs. to 19:55 Hrs. after maintaining all formalities regarding arrest and seizure and brought them to P.S.
