Sir,

With due respect I, SI Maniur Rahaman, beg to submit before you that on 26.04.2020 at about 18:15 Hrs while under signed was on area round duty, found following persons with their Motor Cycles noted against each, were gathered at Zilla School Morh under Purulia (T) PS and detained at the spot. On being asked the following persons could not able to give any satisfactory answer for that gathering on the road. As such the following persons violated the order during this pandemic situation duly promulgated by Ministry of Home Affairs, Govt. of India, vide Order No- 40-3/2020-DM-I (A) dated- 15th April, 2020 to 3rd May 2020. Moreover all the detained persons were making and circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people and as well as the society. Accordingly the following persons were arrested and seized 02 two-wheelers (1) Hero HD Delux Motor Cycle having Reg. No- WB56M 2668, (2) Bajaj Discover Motor Cycle having Reg.
