Sir,

With due respect I beg to submit before you that on 07.04.2020 at about 13:55 Hrs while under signed was on area round duty, found following persons with their Motor Cycles and one four wheeler noted against each, were gathered at Boro Hat morh of Chaibasa Road and detained at the spot. On being asked the following persons could not able to give any satisfactory answer for that gathering on the road. As such the following persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- H & F W/120/20 dated 22.03.2020 which is extended till 14.04.2020. Moreover all the detained persons were making and circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people and as well as the society.
