Sub: Request for lodging F.I.R. against arrested accused Tapas Das (30 yrs) s/o Gobinda Das of Dhobghata Bauri Para (Bulu Doctor Lane), Ward No- 18, PS- Purulia (T), Dist- Purulia and Prop. Nimai Dutta (Hotel Highway) of Dulmi down, PS- Purulia (M), Dist- Purulia u/s- 46A (c) of B.E. Act 1909.

Sir,

In producing herewith arrested accused person Tapas Das (30 yrs) s/o Gobinda Das of Dhobghata Bauri Para (Bulu Doctor Lane), Ward No- 18, PS- Purulia (T), Dist- Purulia under Arrest Memo alongwith seized articles viz. 200 (Two Hundred) bottles of Country Spirit designed as 'Dil Khush' (each bottle contains 600 ml of country spirit having strength 80° UP being sealed properly) Manufactured Blended and bottled by Purulia Bottling Private Ltd, Vill- Lagda, PS- Purulia (M), Dist- Purulia, Pin- 723149 and one White Colour Jeeto Mini Van (LXD) without number plate under proper seizure list and being labeled properly.

I beg to report that today in course of Halla mobile duty at 17:05 hrs, vide C.C.No-876/20, Dated- 07.04.2020 received a telephonic information at 19:15 from source that one person namely Tapas Das (30 yrs) s/o Gobinda Das of Dhobghata Bauri Para (Bulu Doctor Lane), Ward No- 18, PS- Purulia (T), Dist- Purulia was carrying country spirit for selling in a White Colour Jeeto Mini Van (LXD) without number plate on Saheb bandh road, Purulia. Accordingly I informed to O/C, Purulia (T) PS of the matter and thereafter obtaining permission from O/C Purulia (T) PS, I ASI Prabhash Bauri along with C/1098 Tarani Singh Sardar and NVF/445 Rohin Mahato left for working out the information. We reached at Haripada Sahitya Mandir near Rabindra Bhaban, Purulia, detained the above noted Vehicle. We apprehended the vehicle and the driver and on searching the vehicle, we recovered 200 (Two Hundred) bottles of Country Spirit designed as 'Dil Khush'. On being interrogated he revealed his identity as Tapas Das (30 yrs) s/o Gobinda Das of Dhobghata Bauri Para (Bulu Doctor Lane), Ward No- 18, PS- Purulia (T), Dist. - Purulia, driver of the vehicle as well as seller. He had bought the 200 (Two Hundred) 'Dil Khush' bottles illegally from Hotel Highway, Prop. Nimai Dutta of Dulmi down, PS- Purulia (M), Dist- Purulia. On being asked he could not produce any license in favour of carrying, keeping or possessing country spirit for selling purpose. Accordingly I seized 200 (Two Hundred) bottles of Country Spirit designed as 'Dil Khush' from his possession in between 20:25-20:35 Hrs. after labeling and sealing properly. I had taken one bottle of Country Spirit designed as 'Dil Khush' as sample and arrested him at 20:45 Hrs after observing all the formalities regarding arrest, as his offence comes under the ambit of 46A (c) of B.E. Act 1909.

Hence a specific case may kindly be started and arrange for its investigation.
