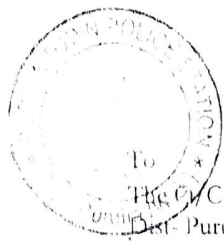

Sir,

With due respect I ASI Sadhan Ch. Danda, beg to submit before you that on 14.04.2020 at about 18:05 Hrs while under signed was on area round duty, found following persons with their Motor Cycles noted against each, were gathered at Old Police Line Morh under Purulia (I) PS and detained at the spot. On being asked the following persons could not able to give any satisfactory answer for that gathering on the road. As such the following persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- H & F W/120/20 dated 22.03.2020 which is extended till 14.04.2020. Moreover all the detained persons were making and circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people and as well as the society. Accordingly the following persons were arrested and seized 01 motor cycle and 01 Scooty from 18:45 Hrs to 20:05 Hrs. after maintaining all formalities regarding arrest and seizure and brought them to P.S


