Sub:- Prayer for lodging FIR against arrested accused Rajib Mahato (34), S/O Sriram Mahato of Joradih, PS - Santaldih and 03 others.

Sir,

With due respect, I, SI Dipankar Biswas of Santaldih Investigation Centre under Santaldih Police Station, beg to submit that today (24/04/2020) at about 16:05 hrs, while myself along with force were performing mobile duty and found the following persons with 02 motor cycles noted against each, were moving aimlessly at Chakbad area, PS - Santaldih. Police party detained them at Chakbad (Birshachak) more on Paharigora to STPS Plant road under Santaldih P.S. and being asked the following persons could not able to give any satisfactory answer for their movement on road and public place. Though lockdown is going on throughout the district of Purulia in view of Pandemic of COVID - 19 outbreak, vide Govt. of India consolidated order No. 40-3/2020-DM-I (A) Date - 24/03/2020 and further modified dated - 25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No. H & F W/120/20 dated 22.03.2020 which is extended till 03.05.2020. Moreover, all the detained persons were refused to comply the direction given by the Central Govt. & State Govt. to combat the rapidity of COVID - 19 pandemic. All the accused persons also tried negligently to spread infection of disease dangerous to life. Accordingly, the following persons were arrested and seized 02 motor cycles under proper seizure list and duly signed by the witnesses and the accused persons, after maintaining all formalities regarding arrest and seizure & prepared arrest memos and brought them to PS.
