Sir,

With due respect, I, SI Sourav Kanti Das of Santaldih Police Station, beg to submit that today (25/04/2020) at about 16:25 hrs, while myself along with force were performing mobile duty and found the following persons with 02 motor cycles noted against each, were moving aimlessly at Shyampur more area under Santaldih PS. Police party detained them at Shyampur more in front of Hero Show Room on Paharigora to STPS Plant road under Santaldih P.S. and being asked the following persons could not able to give any satisfactory answer for their movement on road and public place. Though lockdown is going on throughout the district of Purulia in view of Pandemic of COVID - 19 outbreak, vide Govt. of India consolidated order No. 40-3/2020-DM-I (A) Date - 24/03/2020 and further modified dated - 25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No. H & F W/120/20 dated 22.03.2020 which is extended till 03.05.2020. Moreover, all the detained persons were refused to comply the direction given by the Central Govt. & State Govt. to combat the rapidity of COVID - 19 pandemic. The above noted accused persons also tried negligently to spread infection of disease dangerous to life. Accordingly, the following persons were arrested and seized 02 motor cycles under proper seizure list and duly signed by the witnesses and the accused persons, after maintaining all formalities regarding arrest and seizure & prepared arrest memos and brought them to PS. On being asked they failed to produce any valid documents against the following seized motor cycles

1. Anwar Ansary (32), S/O Lt. Akbar Ansary of Parbahal, PS - Santaldih, Dist. - Purulia.
(One Black colour Bajaj Discover Motor cycle vide Reg. no. WB-56E-4558)
2. Paban Rajwar (24) S/O Santosh Rajwar of Ashurbandh PS - Santaldih, Dist. - Purulia,
3. Rabi Mahato (25) S/O Gorachand Mahato of Bogra, PS - Santaldih, Dist - Purulia **(one Red colour Hero Honda Splendor+ Motor cycle vide Reg. no. WB-56E-6517)**

Under above circumstances, I, therefore, pray that a case 188/269/270/34 IPC & Read with section 51 of Pandemic Digester Management Act, 2005 may kindly be initiated against 1) Anwar Ansary (32), S/O Lt. Akbar Ansary of Parbahal, 2) Paban Rajwar (24) S/O Santosh Rajwar of Ashurbandh, and 3) Rabi Mahato (25) S/O Gorachand Mahato of Bogra, all of PS - Santaldih, Dist - Purulia.
