Sub:- Prayer for lodging FIR against arrested accused (1) Rajesh Mudi (28), S/O Ajit Mudi of Chakbad and (2) Jiten Chowdhury (29), S/O Lt. Lakhan Chowdhury of Chakbad (Ambagan), both of PS -Santaldih, Dist. - Purulia.

Sir,

With due respect, I, SI Partha Pratim Chakraborty of Santaldih Police Station, beg to submit that today (28/04/2020) at about 16:05 hrs, while myself along with force were performing mobile duty and found the above noted persons with one white & blue colour Honda Dio scooty bearing Reg. No. WB-82B-4331, were moving aimlessly at STPS Township Gate no. 1 under Santaldih PS. Police party detained them in front of STPS Township Gate no. 1 on Paharigora to S.T.P.S. Plant road under Santaldih P.S. and being asked they could not able to give any satisfactory answer for their movement on road and public place. Though lockdown is going on throughout the district of Purulia in view of Pandemic of COVID - 19 outbreak, vide Govt. of India consolidated order No. 40-3/2020-DM-I (A) Date - 24/03/2020 and further modified dated - 25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No. H & F W/120/20 dated 22.03.2020 which is extended till 03.05.2020. Moreover, all the detained persons were refused to comply the direction given by the Central Govt. & State Govt. to combat the rapidity of COVID - 19 pandemic. Both the accused persons also tried negligently to spread infection of disease dangerous to life. Accordingly, they were arrested and seized the said (WB-82B-4331) Scooty under proper seizure list and duly signed by the witnesses and the accused persons, after maintaining all formalities regarding arrest and seizure & prepared arrest memos and brought them to PS.

· Under above circumstances, I, therefore, pray that a case 188/269/270/34 IPC & Read with section 51 of Pandemic Digester Management Act, 2005 may kindly be initiated against (1) Rajesh Mudi (28), S/O Ajit Mudi of Chakbad and (2) Jiten Chowdhury (29), S/O Lt. Lakhan Chowdhury of Chakbad (Ambagan), both of PS - Santaldih, Dist. - Purulia.
