Sub: Request for lodging F.I.R. against arrested accused.

Sir.

With due respect I beg to submit before you that on 16.04.2020 at about 22:45 hrs while under signed was on area round duty, received an information that one person namely Subhankar Acherjee S/O Shibmanik Acharjee of Gowalberia, P.S Santuri, Dist. Purulia is coming from Durgapur towards to his native house at Gowalberia under Santuri P.S. where he was working and staying more than 06 months. After getting such information and as per instruction of O/C, Santuri P.S. I alongwith force rushed to Gowalberia village and found that the said person entering into the village. On being asked to verify at first he denied to give his full particulars and showing arrogance to me. Later, he disclosed his identity but could not able to give any satisfactory answer regarding his movement from Durgapur to his native village at Gowalberia during this lock-down period. Moreover I requested him to go Muradih B.P.H.C for quarantine as per Govt. direction. But he does not agree to go to Hospital nor obey any Govt. order. As such the following persons violated the order during this pandemic situation duly promulgated by Ministry of Home Affairs, Govt. of India vide Order No- 40-3/2020-DM-I(A) dated- 15th April, 2020 to 3rd May 2020 and also he violate Section 2 of Epidemic Diseases Act, 1897 and 51(b) of Disaster Management Act. 2005. Moreover he was making and circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people and as well as the society. Accordingly, he was arrested after maintaining all formalities regarding arrest and brought him to P.S.

Hence it is prayed before you that a specific case may kindly be started against the aforesaid arrested person under proper section of law.
