Sub: Request for lodging F.I.R. against arrested accused *Khuraid Ansary & 03 others*

Sir,

In producing here with 04 (Four) arrested accused namely 1. *Khuraid Ansary* (25 Yrs) S/O *Asrafil Ansary* of Vill- *Dabar(Chorpahari)PS-Raghunathpur*, Dist- *Purulia* 2. *Amit Dey* (35 Yrs) S/O *Asit Dey* of *SPG Mission Compound, South Settlement*, PS-*Adra*, Dist- *Purulia* 3. *Paresh Bauri* (38 Yrs) S/O *Taru Bauri* of Vill- *Kada Marrah*, PS-*Raghunathpur*, Dist- *Purulia* 4. *Azad Mukhi* (21 Yrs) S/O *Lt. Rajesh Mukhi* of *Children Park*, PS-*Adra*, Dist- *Purulia* along with 01 seized *Motor Cycle* with seizure list and Memo of Arrest. Seized 01 *Motorcycle* is noted below.

1. One red color new *Honda CB Shine Motor Cycle* vide Eng. No- *JC73EG0115164* from the possession of *Azad Mukhi* (21 Yrs) S/O *Lt. Rajesh Mukhi* of *Children Park*, PS-*Adra*, Dist- *Purulia*.

I SI *Subrata Sadhu* of *Adra PS* do here by lodged a complaint against above noted 04 accused persons to the effect that on 01.05.2020 at about 15.35 hrs while I was on patrolling duty, found 10-12 persons consist of their 03-04 *Motorcycle* gathered at *CI More*, *South Settlement*, PS-*Adra*, Dist- *Purulia*. After seeing the police party 06-08 persons consist of their respective 02-03 *Motorcycle* were fled away. Rest persons also tried to fled away but after reached the spot we managed to detained 04 persons and 01 *Motorcycle*. On being asked the following persons could not able to give any satisfactory answer for that gathering on the road or they could not able to give reasonable ground for this gathering. Though lockdown is going on throughout the District of *Purulia* in view of *Pandemic of COVID-19 outbreak* vide *Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020* and further modified dated-*25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020* and *10/04/2020* for complete restriction measure As such the above persons violated the order during this pandemic situation duly promulgated by *Govt. of West Bengal* vide *Order No- H & F W/120/20 dated 22.03.2020* which is extended till *03.05.2020*. Accordingly the following 04 (Four) persons were arrested from 16:25 Hrs. to 16:55 Hrs. after maintaining all formalities regarding arrest and brought them to P.S. I offered them for medical treatment but they denied.

Hence I there for pray that a specific case may kindly be started against above mentioned persons U/S 188/34 IPC & Section 51 (1) (b) in the *National Disaster Management Act, 2005*.
