Sambhu Pandey (22 Yrs) S/O Chandradhar Pandey of Vill- Arabinda Colony near DVC More Adra, PS-Adra, Dist- Purulia (2) Sudhama Swarnakar (39 Yrs) S/O Lt. Munib Swarnakar near Chhoto Hospital Adra, PS-Adra, Dist- Purulia along with 01 seized Motor Cycle with seizure list and Memo of Arrest. Seized 01 Motorcycle is noted below.

One white and blue color new Honda Scotty vide Eng. No-JF39ED0005349
from the possession of Sambhu Pandey (22 Yrs) S/O Chandradhar Pandey of
Vill- Arabinda Colony near DVC More Adra, PS-Adra, Dist- Purulia.

I SI Manas Kr. Panda of Adra PS do here by lodged a complaint against above noted 02 accused persons to the effect that on 08.05.2020 at about 17.35 hrs while I was on patrolling duty, found 05-06 persons consist of their 02-04 Motorcycle gathered at Monpura More, North Settlement, PS-Adra, Dist- Purulia. After seeing the police party 03-04 persons consist of their respective 02-03 Motorcycle were fled away. Rest persons also tried to fled away but after reached the spot we managed to detained 02 persons and 01 Motorcycle. On being asked the following persons could not able to give any satisfactory answer for that gathering on the road or they could not able to give reasonable ground for this gathering. Though lockdown is going on throughout the District of Purulia in view of Pandemic of COIVD-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- H & F W/120/20 dated 22.03.2020 which is extended till 03.05.2020. Accordingly the following 02 (Two) persons were arrested from 18:15 Hrs. to 18:25 Hrs. after maintaining all formalities regarding arrest and brought them to P.S. I offered them for medical treatment but they denied.

Hence I there for pray that a specific case may kindly be started against above mentioned persons U/S 188/34 IPC & Section 51 (1) (b) in the National Disaster Management Act, 2005.
