Sir,

In producing here with 01 (One) arrested accused namely 1. Manas Mukharjee (40 Yrs) S/O Lt. Jagabandhu Mukharjee of Misson Para (Arobinda Polly), PS-Adra, Dist-Purulia and Memo of Arrest and connecting papers.

I SI Subrata Sadhu of Adra PS do here by lodged a complaint against above noted 01 accused person to the effect that on 15.05.2020 at about 16.35 hrs while I was on patrolling duty and miking was done regarding Govt. Instruction and awareness from R.T mobile van then found 08-10 persons gathered in front of "GOKUL SWEET" shop, near accounts office Adra South Side, PS-Adra, Dist-Purulia. Shop attended also was without mask and he also did not tried to maintain social distance among the gathering in front of his shop. When I, reached the spot and tried to brief them regarding the current pandemic situation and also tried to disburse the gathering then the persons and the shop attendant did not pay any heed to me and even the shop attended shows rough behavior to me. Finding no other way I tried to detain them but all of them expect the shop attended manage to fled away. On being asked the above noted person i.e. the shop attended Manas Mukharjee could not able to give any satisfactory answer for that gathering in front of the shop or they could not able to give reasonable ground for this gathering and non wearing musk. Though lockdown is going on throughout the District of Purulia in view of Pandemic of COIVD-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020, 10/04/2020 and 01/05/20 for complete restriction measure As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- H & F W/120/20 dated 22.03.2020 which is extended till 17.05.2020. He also malignantly doing an activity from which the infection of disease likely to spread. Accordingly the above noted 01 (One) person was arrested at 17:35 Hrs. after maintaining all formalities regarding arrest and brought them to P.S. I offered him for medical treatment but he denied.

Hence I there for pray that a specific case may kindly be started against above mentioned persons U/S 186/188/270/34 IPC & Section 51 (1) (b) in the National Disaster Management Act, 2005.
