Sir,

In producing herewith 02 (Two) accused persons namely 1. Chabilal Mahato, S/O-Lt-Thakurdas Mahato & 2. Pabitra Kumar, S/O-Sunil Kumar both of Vill-Kushaldih, PS-Baghmundi, Dist-Purulia to the effect that on 09/05/2020 at about 16:45 hrs while I SI Biswajit Banerjee along with force C/162 Umesh Mandi, C/673 Pintu Gorain, C/773 Sudarshan Majhi all of SAP 11th Bn. Camp at Baghmundi PS were performing mobile duty vide Baghmundi PS GDE No- 374, Dated- 09/05/2020 and C.C No-598/20 Date-09/05/2020. During my mobile duty when myself along with force reached at Kushaldih More and found two persons were roaming aimlessly at Kushaldih More on Baghmundi- Jhlda main road without mask or its alternative. I detained them. On being asked the above accused persons disclosed their identity as above but could not able to give any satisfactory answer for that movement on road and public place. Though lockdown is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- H & F W/120/20 dated 22.03.2020 which is extended till 17.05.2020. Moreover all the detained persons were refuses to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic.

Hence I pray before you to start a specific case against the above noted persons under proper section of law.
