Sir,

In producing herewith 01 (One) accused persons namely Pranath Mahato (40 Yrs), S/O-Lt-Srishtidhar Mahato of Vill-Bareria, PS-Baghmundi, Dist-Purulia to the effect that on 13/05/2020 at about 19:25 hrs while I SI Sudhir Kumar Mahato along with force C/673 Pintu Gorain, C/773 Sudarshan Majhi both of SAP 11th Bn. Camp at Baghmundi PS and JC/549 Arun Kumar Duley of Baghmundi PS were performing mobile duty vide Baghmundi PS GDE No- 547, Dated- 13/05/2020 and C.C No-630/20 Date-13/05/2020. During my mobile duty when myself along with force reached at Bareria More and found the above noted person is roaming aimlessly at Bareria More on Baghmundi- Ajodhya Hill Top road without mask or its alternative. I detained him. On being asked the above accused person disclosed his identity but could not able to give any satisfactory answer for that movement on road and public place. Though lockdown is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated- 25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure. As such the above person violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- H & F W/120/20 dated 22.03.2020 which is extended till 17.05.2020. Moreover the detained person is refuses to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic.

Hence I pray before you to start a specific case against the above noted person under proper section of law.
