Sir,

In producing herewith one arrested accused person namely Ajit Kumar S/O Abani Kumar of Vill- Pathardih (Kumarpara), PS- Baghmundi, Dist- Purulia along with one seized motor cycle, Maroon & Black Colour bearing chasis no- MD634BE44J2A31116 and Eng No- BE4AJ2829328 and a number plate attached in the back side in which Registration No WB 56M/7434 is reflected and lodging a written complaint against him, to the effect that today i.e on 24.05.2020 at 10.25 hrs while I was performing Naka Duty at Link Road, Baghmundi, PS- Baghmundi, Dist- Purulia along with C/564 Prasad Majhi, C/1319 Soumen Koley and JC/2422 Haren Ch. Gorai vide Baghmundi P.S. GDE No.- 1033, Dated-24.05.2020 and C.C. No 710/2020, Dated-24.05.2020, I detained the above noted Motor Cycle and asked its above noted rider to produce the relevant documents of the said Motor Cycle. The said rider failed to produce the same and tried to escape from the spot. We somehow managed to catch him and interrogate him. During interrogation he confessed that the seized motor cycle was procured by means of theft and he has been engaged in dealing with those kind of stolen motor cycle since long. He further disclosed that recently he had a stolen motor cycle and would help us to recover a good number of stolen motor cycle if get a chance as well as to secure arrest of their gang members. Accordingly I seized the above noted Motor Cycle with proper seizure list duly signed by witnesses. I also arrested the said person maintaining all legal formalities

Hence I pray before you to start a case against this person U/S- 379/411/413/414 IPC and oblige.
