In producing here with the following seized motorcycles 1) One grey colour Honda Shine Motor Cycle having No- JH 05 CH 9743 and 2) One Red colour Hero Honda Splender + without number plate & tempered engine, chasis number and do here by lodge a suo motu complaint against the owner of above noted Motorcycles.

Today (07/05/2020) myself SI Satrughna Mahato along with force C/649 Digam Ch. Mahato & JC/ 637 Dinesh Mahato were engaged in Spl. mobile duty vide CC NO- 1954/20, GDE no- 293 dt- 07.05.20 and as per direction we were engaged for implementation of Govt. rules regarding Lockdown and disaster management plan. At about 20:15 Hrs, when myself along with force reached at Balarampur Bus stand under Balarampur P.S. we found 02 (two) Motor cycles with three riders in each Motor cycles not wearing mask were plying in excessive speed, making chaos in the area. We tried to intercept them But riders of Motor cycles fled away seeing Police party leaving 02 (two) Motor Cycles on road. We tried to apprehend them but failed. So, there is every reason to believe that the riders of those 02 (Two) Motorcycles came out from their home and moving aimlessly for making fun. Though lockdown is going on throughout the District of Purulia in view of Pandemic of COIVID-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated- 25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- H & F W/120/20 dated 22.03.2020 which is extended till 03.05.2020. Later on order extended to 17.05.20. Therefore they disobeyed Govt. order and committed negligent act likely to spread infection of diseases dangerous to life and violated Quarantine rule. So, I seized those above noted Motor cycles with proper seizure list.

Under the above circumstances, I pray that a cognizable case may kindly be started against the owner of the following motorcycles.

1. One grey colour Honda Shine Motor Cycle having No- JH 05 CH 9743 and
- 2) One Red colour Hero Honda Splender + Motor Cycle without number plate & tempered engine, chasis number.
