Sir,

In producing here with the arrested accused namely Manoj Singh Modak (Male / 38 yrs.) S/O Late Mihir Singh Modok of Vill.- Barabazar (Chawakbazar) P.O- Barabhum, P.S- Barabazar, Dist.- Purulia with all connected papers after medical examination from Barabazar B.P.H.C.

I beg to state that today (16/05/2020), I along with my accompanied officer ASI Manas Kr. Pan with C/665 Rabindranath Goral & C/975 Ashok Saha Roy left for Barabazar market area with intend to observe Lock Down order passed by the State Government of W.B to prevent attack from CORONA VIRUS/COVID-19 vide Barabazar PS G.D entry no 834 Dtd. 16/05/2020. At about 06.35 hrs I reached near Barabazar shop styled as "Hotel Sonakshi Chawakbazar and found and Fast one near Chawakbazar more has been opened. We apprehended the above noted accused person.

I was directed to find out whether the lock down has been implanted properly by shopkeepers at Barabazar market area or not. Accordingly, I had been to here & there at market area and when I reached near Chawakbazar More, Barabazar around 06.35 hrs and found that a gathering appeared in front of the aforesaid Hotel cum fast food which is opened and selling other than Non essential articles as well as sweet by the above noted shopkeeper. Seen the Police party the mob fled away.

Though lockdown is going on throughout the District of Purulia in view of Pandemic of COIVD-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- H & F W/120/20 dated 22.03.2020 which is extended till 17.05.2020.

Held an enquiry and from the locality it came to light that name & address of the shop keeper is Manoj Singh Modak (Male / 38 yrs.) S/O Late Mihir Singh Modok of Vill.- Barabazar (Chawakbazar) P.O-Barabhum, P.S- Barabazar, Dist.- Purulia who opened his Hotel cum fast Food shop, selling sweet which is non essential goods & disobedience to order duly promulgated by govt. through public servants and through media etc for prevention of attack from CORONA Virus. It is also revealed that said shopkeeper is very desperate, creating annoyance to the society by such type of illegal activities avoiding govt order in this critical situation. The ambience of the shop and the shop keeper was found very much unhygienic and without any health care articles. This may spread infection. His malignant act is likely to spread infection of disease dangerous to life.

Finding no other alternative to prevent such type of activities and violation of Govt order I arrested the involved Shopkeeper Manoj Singh Modak (Male / 38 yrs.) S/O Late Mihir Singh Modok of Vill.- Barabazar (Chawakbazar) P.O- Barabhum, P.S- Barabazar, Dist.- Purulia by issuing memo of arrest .As there was lock down in the town and Police appeared suddenly, the peoples left the place and did not agreed to come forward to remain present as witness. I also refrained myself from encouraging much people to come out from home to remain present in the Police work in this time of Lock Down. I took photograph of the open shop. After maintaining all formalities I arrested the aforesaid accused persons and issued arrest memo by informing the ground of arrest and also informed to his relatives. He also medically checked up.

After that I left for PS. On arrival at PS I type this letter of complaint at our PS computer and submitted to I.C Barabazar through duty officer SI Basudeb Acharya for taking necessary action against said arrested shopkeeper namely Manoj Singh Modak (Male / 38 yrs.) S/O Late Mihir Singh Modok of Vill.-Barabazar (Chawakbazar) P.O- Barabhum, P.S- Barabazar, Dist.- Purulia as per law.
