Sunil Mandal of Vill- Dhangargora, PS- Hura Dist-Purulia and five others to the effect that on 11/05/2020 in course of mobile duty at about 11:00 hrs noticed that some supporters of B.J.P. with party flag under the leadership of Abdul Goffar Ansary assembled in an open filled beside under construction building of Smt Pratima Tudu Prodhan of Rakhera Bishpuria G.P. near Kumardih village beside Kumardih village to Bishpuria village road without obtaining permission. As per Govt. circular, the political programs irrespective of all political parties are restricted in this pandemic situation. On received the such information reached there at 11.25 hrs and on seeing police van they all managed to escape from there. V.P Satyajit Mahato & CVF Pintu Mahato who were engaged road watch duty saw and opposed them not to do the such type of political program and also taken some photographs about their assembled. Local enquiry revealed that above noted persons assembled there with party flag of B.J.P.

Moreover all the persons were making and circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people and as well as the society and give provocation to the people to break public peace or to commit other offence making conspiracy. They also disobeyed the Government Order regarding recent pandemic situation for attacking of Corona virus throughout the India as well as whole World.
