With due respect I do hereby lodge a written complaint against the arrested accd persons namely (1) Parimal Tudu (26) S/O Lt. Barkanath Tudu, of Vill- Chiragora (Motipur), PS- Hura, Dist.- Purulia (2) Mitān Mahato (31) S/o Ajit Mahato, Vill- Motipur, PS- Hura, Dist.- Purulia (3) Gour Mahato (19) S/O- Dilip Mahato, Vill- Motipur, PS- Hura, Dist.- Purulia (4) Manik Mahato (27) S/O- Dilip Mahato, Vill- Bishpuria (Namopara), PS- Hura, Dist.- Purulia to the effect that on 16.05.2020 at about 19:35 hrs while I SI Malay Rajak along with force were performing night mobile duty vide Hura PS GDE No- 1188 Dated- 16.05.2020 and CC No 1432/20 dtd. 16.05.20 and found the arrested above noted persons and one Motor Cycle with three persons were roaming aimlessly at Nimtola more area. Police party detained them at Nimtola more on NH60A (Bankura - Purulia pitch road) under Hura PS. On being asked the above accused persons could not able to give any satisfactory answer for that movement on road and public place. Though lockdown is going on throughout the District of Purulia in view of Pandemic of COIVD-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020, 10/04/2020 and 02/05/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- H & F W/120/20 dated 22.03.2020 which is extended to till 21.05.2020. Moreover all the detained persons were refuses to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic. All the accused persons also tried negligently to spare infection of disease dangerous to life. So I arrested them and seized one Motor Cycle bearing registration no. WB 56J/4371 with proper seizure list duly signed by the witnesses.

So I, therefore, lodged a complaints against the arrested accd persons persons namely (1) Parimal Tudu (26) S/O Lt.
