In producing herewith four arrested accd persons namely (1) Ambuj Mudi 18 years 5/o Neharu Mudi (2) Pallab Mahato 20 years S/O Kiriti Mahato (3) Chiranjit Mudi 20 years S/O Jaharlal Mudi all of Vill- Kudlung, PS- Hura Distantic and (4) Selling and (4) Selling and (4) Selling and (4) Selling and (5) Selling and (6) Selling and ( Purulia and (4) Salim Ansary 19 years S/O Kalimulla Ansary of Vill- Dumdumi PS Hura Dist- Purulia and four seized tractors attached with approx 100 Cft. sand loaded in each trolley as per seizure list. I ASI Biswajit Kalindi of Hura PS lodged a complaint against the owner and driver of the seized tractors. To the effect that on 03/05/2020 at 08:15 Hrs. while I was engaged mobile duty at PS area received a source information from my reliable source that some tractors with trolley mentioned above was coming from Kansai River side towards Arjunjora village having loaded with sand without any royalty/challan. This information communicated to O/C Hura PS for onward transmutation. As per direction of O/C Hura PS, I ASI Biswajit Kalindi and force namely 1) Constable-516 Chandra Sekhar Mahato, 2) Constable-118 Dijapada Mahato, HG- 1535 Provas Ruhidas rushed to the spot to work out the source information. We reached at Beltal under Rakab Jungle near Kudlung Village at 09:05 hrs on jungle moram road we found that four tractors with trolley were coming. Then I detained said tractors & trolley and found the said tractors & trolley loaded with sand approx 100 Cft. in each. I asked the drivers of the said tractors to produce valid document /challan in respect of the sand but they were unable to produce the same. Accordingly I seized the offending vehicles as (1) one blue colour Powertrac tractor having Reg No- WB-55A/7587 Chassis No- T053371429LG Eng No- E3416860 with one sand loaded trolley approx 100 Cft having Reg No- WB-55A/6367 (2) one red colour Mahindra, B275, DI tractor having Reg No-WB-55B/1728, Chassis No- MBNABAEXPKRL06573, Eng No- RKL2EAN0512 with one sand loaded trolley approx 100 Cft having Reg No-WB-55B/2211 (3) one blue colour Powertrac Tractor having Reg No- WB55A/6367, Chassis No- T053331688MF Eng No-E3371695 with one sand loaded trolley approx 100 Cft having Reg No- WB-55A/7587 and (4) one blue colour without registration Sonalika International tractor having Eng No-3100FL533F352006F2, Chassis No- HZUSV352298SM with one sand loaded old trolley approx 100 Cft sand after preparing proper seizure list duly signed by accompanied Police persons and drivers of the seized tractors. Because of unavailability of the local people due to Jungle area I could not put

On close interrogation of the drivers it is learnt that the owner and the driver of the tractors are stolen away sand from Kansai River bed in a clandestine manner and they are involved in illegal business for gain. It is also learnt that one Sandip Mahato S/O Shibaprasad Mahato of Vill- Arjunjora PS- Hura Dist- Purulia and Kallimulla Ansary S/O Kurban Ansary of Vill- Dumdumi PS- Hura Dist- Purulia are the master mined in this said sand smuggling racket. Then I arrested the four Accd drivers namely (1) Ambuj Mudi 18 years S/O Neharu Mudi (2) Pallab Mahato 20 years S/O Kiriti Mahato the four Accd drivers namely (1) Ambuj Mudi all of Vill- Kudlung, PS- Hura Dist- Purulia and (4) Salim Ansary 19 years S/O (3) Chiranjit Mudi 20 years S/O Jaharlal Mudi all of Vill- Kudlung, PS- Hura Dist- Purulia and (4) Salim Ansary 19 years S/O Kalimulla Ansary of Vill- Dumdumi Ps Hura Dist Purulia. I issued them memo of arrest.

Therefore I request that a specific case may kindly be registered against the drivers namely(1) Ambuj Mudi S/o Neharu Mudi (2) Pallab Mahato S/O Kiriti Mahato (3) Chiranjit Mudi S/O Jaharlal Mudi all of Vill- Kudlung, PS- Hura Dist-Purulia and (4) Salim Ansary S/O Kalimulla Ansary of Vill- Dumdumi Ps Hura Dist Purulia, owner of the four seized tractors having (5)Reg No- WB-55A/7587 (6) Reg No-WB-55B/1728, (7) Reg No- WB55A/6367 and (8) tractor having Eng tractors having (5)Reg No- WB-55A/7587 (6) Reg No-WB-55B/1728, (7) Reg No- WB55A/6367 and (8) tractor having Eng No-3100FL533F352006F2, Chassis No- HZUSV352298SM (9) Sandip Mahato S/O Shibaprasad Mahato of Vill- Arjunjora PS- Hura Dist- Purulia (10)Kallimulla Ansary S/O Kurban Ansary of Vill- Dumdumi PS- Hura Dist- Purulia under proper section of law and arrange for its investigation.
