Sir,

I, ASI Dulal Singh Sardar along with force return to PS and brought under seizure 02(two) seized Tractors- (i) WB55A 6516, Engine no- RFN05952, Chasis No- RFNE05952 (ii) WB55 7426 (Number plate not readable properly) both are attached with a sand loaded trolley and lodged this complaint to the effect that today(09.05.2020) during day mobile duty at about 16:45 hrs received a credible source information that 02 (two) tractors was carrying sand illegally and coming from Tulin ghat & going towards Jhalda side. Accordingly, myself along with force left to work out the said source information. This refers to Jhalda PS GDE No- 287 Dated- 09/05/2020 & Jhalda PS CC No- 1410 Dated- 09/05/2020. Then, we intercept the said vehicles near Khatjuri village (Purulia Ranchi road) under Jhalda PS at about 17:35 hrs and found the above noted tractors were tagged with a trolley both loaded with sand. But seeing the Police Party drivers of both Tractors and others fled away leaving their Tractors on road. We tried to apprehend them but failed. We waited for reasonable time but none came to spot. So there is every reason to believe that the owners, drivers and others of above noted 02 Tractors dealing in sand business in clandestine manner and they do not have any proper challan or any documents related to loaded sand of above detained 02 (Two) Tractors. So I, seized above noted 02 (Two) Tractors (i) WB55A 6516, Engine no- RFN05952, Chasis No- RFNE05952 (ii) WB55 7426 (Number plate not readable properly) with attached sand loaded Trolley(approx 100 cft) each.

On return to P.S., kept the sand loaded seized vehicles at PS compound and I do here by submitting written complaint before you to start a cog case against (i) Owner of Tractor WB55A 6516, Engine no- RFN05952, Chasis No- RFNE05952 (ii) Owner of Tractor WB55 7426 (Number plate not readable properly) (iii) Driver of Tractor WB55A 6516, Engine no- RFN05952, Chasis No- RFNE05952 (iv) Driver of Tractor WB55 7426 (Number plate not readable properly) & others under proper section of law.
