Sir,

I, SI- Nimai Ch. Nemo of Jhalda P.S. returned to PS with force and brought under seizure 1) One Red & Black colour Honda Motor Cycle having No- WB56P 6564 2) One black colour Hero Splender Plus Motor Cycle having No- JH01CV 1516 3) One Black & Yellow colour Honda Scooty having no JH01DC 8784 4) One White & Red colour Hero HF Delux Motor Cycle without no. plate having Chasis No- MBLHA11ATG9B35718 and lodged this complaint against 1) Imran Khan (32) S/O Sabir Khan of Vill- Hussendih, PS- Jhalda, Dist- Purulia 2) Anwar Khan (30) S/O Amir Khan of Do 3) Sk. Wahadat (32) S/O Jabir Hussain of Do 4) Chiranjit Kumar (21) S/O Khetramohan Kumar of Vill- Birudih, PS- Jhalda, Dist- Purulia 5) Tapas Kumar (19) S/O Chandmukh Kumar of Do 6) Rahul Mandal (20) S/O Mihir Mandal of Do 7) Owner of Motor Cycle having No- JH01DC 8784 8) Owner of White & Red colour Hero HF Delux Motor Cycle without no. plate having Chasis No- MBLHA 11ATG9B35718 and others to the effect that today (15/05/2020) myself along with force C/571- Md. Hasib Khan and C/386- Sibendu Sinha was engaged in Spl. mobile duty. During Spl. Mobile duty as per direction we were engaged for implementation of Govt. rules regarding Lockdown and disaster management plan. At 19.35 Hrs. when myself with force was performing Naka checking at Birsha more under Jhalda P.S. above noted Motor cycles with three riders were detained as they were moving aimlessly and creating Halla. Three riders of Two Motor Cycles having No- WB56P 6564 & JH01CV 1516 could be apprehended but riders of rest Two Motor Cycles fled away leaving their Motor cycles on spot. We tried our level best to apprehend them but failed. I examined detained persons and during examination they disclosed their identity as noted above but they did not give proper reason why they came out from house and reached there. It is known that SI No. 1) to 3) were riding in the Motor Cycle having No- WB56P 6564 and SI No. 4) to 6) were riding in the Motor Cycle having No - JH01CV 1516. They could not produce any documents related to their Motorcycles. So, there is every reason to believe that the riders of those Motorcycles came out from their home and moving aimlessly or making fun and they did not came for emergency purpose. Though lockdown is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- H & F W/120/20 dated 22.03.2020 which is extended till 03.05.2020. Later on the order is extended till 17/05/2020. Therefore they disobeyed Govt. order and committed negligent act likely to spread infection of diseases dangerous to life and violated Quarantine rule. So, I seized those Motor cycles with proper seizure list. I also arrested above noted accd. persons maintaining all formalities of arrest and later on released on bail considering present situation of epidemic COVID-19.

Therefore, I pray a specific case may kindly be lodge against 1) Imran Khan (32) S/O Sabir Khan of Vill- Hussendih, PS- Jhalda, Dist- Purulia 2) Anwar Khan (30) S/O Amir Khan of Do 3) Sk. Wahadat (32) S/O Jabir Hussain of Do 4) Chiranjit Kumar (21) S/O Khetramohan Kumar of Vill- Birudih, PS- Jhalda, Dist- Purulia 5) Tapas Kumar (19) S/O Chandmukh Kumar of Do 6) Rahul Mandal (20) S/O Mihir Mandal of Do 7) Owner of Motor Cycle having No- JH01DC 8784 8) Owner of White & Red colour Hero HF Delux Motor Cycle without no. plate having Chasis No- MBLHA 11ATG9B35718 and others as they disobey Govt. order and committed negligent Act likely to spread infection of diseases dangerous to life and violated Quarantine rule U/S 188/269/270/271 IPC and 51 Disaster Management Act, 2005 and arrange for investigation.
