Sir,

I, SI- Bikash Ch. Patra of Jhalda P.S. returned to PS with force and brought under seizure 1) One Black & White colour Hero Splendar Plus Motor Cycle having No- JH05 CB3155 2) One Black & Blue colour Hero Super Splendar Motor Cycle having No- JH09AM 8735 3) One Black & Red colour Hero Super Splendar Motor Cycle having No- JH01DF 6565 and lodged this complaint against 1) Darasing Kalindi (19) S/O Dhruba Kalindi of Vill- Jamlahar, PS- Jhalda, Dist- Purulia 2) Bibek Tewari (19) S/O Bholanath Tewari of Vill- Meshya, PS- Jhalda, Dist- Purulia 3) Mohitosh Mahato (19) S/O Giridhari Mahato of Vill- Jamlahar, PS- Jhalda, Dist- Purulia 4) Gopal Mahato (19) S/O Dibakar Mahato of Vill- Ulugoria, PS- Arsha, Dist- Purulia 5) Labin Mahato (21) S/O Bibhuti Mahato of Do 6) Sourav Mahato (19) S/O Suchand Mahato of Do. 7) Owner of Motor Cycle having No- JH01DF 6565 and others to the effect that today (16/05/2020) myself along with force C/682- Mahadeb Rajak, NVF/778- Samir Mahato and HG/1681- Manmatha Kumar was engaged in evening mobile duty. During evening mobile duty as per direction we were engaged for implementation of Govt. rules regarding Lockdown and disaster management plan. At 20.05 Hrs. when myself with force was performing Naka checking at Jhalda Bus Stand under Jhalda P.S. above noted Motor cycles with three riders were detained as they were moving aimlessly and creating Halla. Three riders of Two Motor Cycles having No- JH05 CB3155 & JH09AM 8735 could be apprehended but riders of rest Motor Cycle having No- JH01DF 6565 fled away leaving their Motor cycle on spot. We tried our level best to apprehend them but failed. I examined detained persons and during examination they disclosed their identity as noted above but they did not give proper reason why they came out from house and reached there. It is known that SI No. 1) to 3) were riding in the Motor Cycle having No- JH05 CB3155 and SI No. 4) to 6) were riding in the Motor Cycle having No - JH09AM 8735. They could not produce any documents related to their Motorcycles. So, there is every reason to believe that the riders of those Motorcycles came out from their home and moving aimlessly or making fun and they did not come for emergency purpose. Though lockdown is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- H & F W/120/20 dated 22.03.2020 which is extended till 03.05.2020. Later on the order is extended till 17/05/2020. Therefore they disobeyed Govt. order and committed negligent act likely to spread infection of diseases dangerous to life and violated Quarantine rule. So, I seized those Motor cycles with proper seizure list. I also arrested above noted accd. persons maintaining all formalities of arrest and later on released on bail considering present situation of epidemic COVID-19.

Therefore, I pray a specific case may kindly be lodge against 1) Darasing Kalindi (19) S/O Dhruba Kalindi of Vill- Jamlahar, PS- Jhalda, Dist- Purulia 2) Bibek Tewari (19) S/O Bholanath Tewari of Vill- Meshya, PS- Jhalda, Dist- Purulia 3) Mohitosh Mahato (19) S/O Giridhari Mahato of Vill- Jamlahar, PS- Jhalda, Dist- Purulia 4) Gopal Mahato (19) S/O Dibakar Mahato of Vill- Ulugoria, PS- Arsha, Dist- Purulia 5) Labin Mahato (21) S/O Bibhuti Mahato of Do 6) Sourav Mahato (19) S/O Suchand Mahato of Do. 7) Owner of Motor Cycle having No- JH01DF 6565 and others as they disobey Govt. order and committed negligent Act likely to spread infection of diseases dangerous to life and violated Quarantine rule U/S 188/269/270/271 IPC and 51 Disaster Management Act, 2005 and arrange for investigation.
