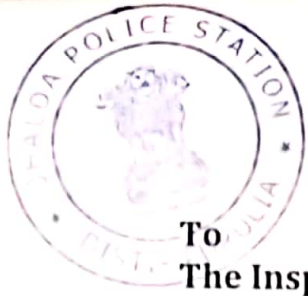

Sir,

I, SI- Bikash Ch. Patra of Jhalda P.S. returned to PS with force and brought under seizure 1) One Red Colour Hero Splendar Plus Motor Cycle having No- WB56N 2458 2) One Black & Yellow colour Yamaha Saluto Motor Cycle having No- WB56N 4932 3) One Black & Red colour TVS Excel Hundred Heavy duty Motor Cycle having No- WB56N 9319 and lodged this complaint against 1) Bijay Karmakar (31) S/O Sumant Karmakar of Jhalda Poddarpara Ward No- VIII, PS- Jhalda, Dist- Purulia 2) Amit Kumar (28) S/O Guruprasad Kumar of Jhalda Chatani Para, Ward No- 05, PS- Jhalda, Dist- Purulia 3) Abhisek Keshri (26) S/O Lt. Narendranath Keshri of Jhalda Bus Stand Ward No- 05, PS- Jhalda, Dist- Purulia 4) Mahesh Keshri (24) S/O Mukesh Keshri of Jhalda Ward No- 04, PS- Jhalda, Dist- Purulia 5) Owner of Motor Cycle having No- WB56N 2458 6) Owner of Motor Cycle having No- WB56N 9319 and others to the effect that today (17/05/2020) myself along with force C/682- Mahadeb Rajak, NVF/778- Samir Mahato and HG/1681- Manmatha Kumar was engaged in evening mobile duty. During evening mobile duty as per direction we were engaged for implementation of Govt. rules regarding Lockdown and disaster management plan. At 19.45 Hrs. when myself with force was performing Naka checking at Jhalda Birsha more under Jhalda P.S. above noted Motor cycles with three riders were detained as they were moving aimlessly and creating Halla. Among three riders of Motor Cycles having No- WB56N 2458 one person could be apprehended and rest 02 (two) persons fled away. Three riders of Motor Cycles having No- WB56N 4932 could be apprehended, but riders of rest Motor Cycle having No- WB56N 9319 fled away leaving their Motor cycle on spot. We tried our level best to apprehend them but failed. I examined detained persons and during examination they disclosed their identity as noted above but they did not give proper reason why they came out from house and reached there. It is known that SI No. 1) was riding in the Motor Cycle having No- WB56N 2458 and SI No. 2) to 4) were riding in the Motor Cycle having No - WB56N 4932. They could not produce any documents related to their Motorcycles. So, there is every reason to believe that the riders of those Motorcycles came out from their home and moving aimlessly or making fun and they did not come for emergency purpose. Though lockdown is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- H & F W/120/20 dated 22.03.2020 which is extended till 03.05.2020. Later on the order is extended till 31/05/2020. Therefore they disobeyed Govt. order and committed negligent act likely to spread infection of diseases dangerous to life and violated Quarantine rule. So, I seized those Motor cycles with proper seizure list. I also arrested above noted accd. persons maintaining all formalities of arrest and later on released on bail considering present situation of epidemic COVID-19.

Therefore, I pray a specific case may kindly be lodge against 1) Bijay Karmakar (31) S/O Sumant Karmakar of Jhalda Poddarpara Ward No- VIII, PS- Jhalda, Dist- Purulia 2) Amit Kumar (28) S/O Guruprasad Kumar of Jhalda Chatani Para, Ward No- 05, PS- Jhalda, Dist- Purulia 3) Abhisek Keshri (26) S/O Lt. Narendranath Keshri of Jhalda Bus Stand Ward No- 05, PS- Jhalda, Dist- Purulia 4) Mahesh Keshri (24) S/O Mukesh Keshri of Jhalda Ward No- 04, PS- Jhalda, Dist- Purulia 5) Owner of Motor Cycle having No- WB56N 2458 6) Owner of Motor Cycle having No- WB56N 9319 and others as they disobey Govt. order and committed negligent Act likely to spread infection of diseases dangerous to life and violated Quarantine rule U/S 188/269/270/271 IPC and 51 Disaster Management Act, 2005 and arrange for investigation.
