Sir,

I, Goutam Kr. Mahata, Sub-Inspector of Police, I/C Tulin OP under Jhalda Police station, Dist-Purulia do hereby lodge this complaint to the effect that today i.e. on 21.05.20 at 10:35 hrs. on receipt of a telephonic information regarding obstruction of West Bengal state Highway road (SH-4A) at Tulin Hut bagan more on Purulia Ranchi road, when myself along with ASI Nisith Ch. Das, C/605 Bapan Biswas, JC/1369 Pradip Bhagat, JC/820 Sanjoy Dey, and JC/1399 Sk. Sultan engaged in Mobile duty Vide Tulin OP CC No- 30/2020, GDE No-646 dated- 21.05.20 and as per direction engaged for implementation of Govt. rules regarding Lockdown and disaster management plan, we left for Tulin Hut bagan, PS-Jhalda, Dist-Purulia. After reaching the spot at about 10:45 hrs, we found that State High way -4A at Tulin Hut bagan More has been blocked by the following persons having been identified by the local source and as well as local police friend at the spot namely (i) Santosh Chel S/O Lt. Mathur Chel of vill-Tulin Namopara, PS- Jhalda, Dist- Purulia (ii) Tarunkanti Pandey S/O Lt. Badyanath Pandey of vill- Tulin Laxmimela, PS- Jhalda, Dist- Purulia (iii) Debdas Gorai S/O Rameshwar Gorai of vill- Tulin Bartal, PS- Jhalda, Dist- Purulia (iv) Bishwapati Dey S/O Lt. Subodh Dey of vill- Tulin Uparpara, PS- Jhalda, Dist- Purulia (v) Pranab Chandra S/O Lt. Anil Chandra of vill- Tulin Uparpara PS- Jhalda, Dist- Purulia (vi) Ashim Saw S/O Lt. Chandrika Saw of vill- Tulin Uparpara, PS- Jhalda, Dist- Purulia (vii) Sankar Paramanik S/O Lt. Bholanath Paramanik of vill- Tulin Uparpara, PS- Jhalda, Dist- Purulia (viii) Chiku Gorain S/O Rameswar Gorain of Tulin Bartal, PS- Jhalda, Dist- Purulia (ix) Jadav Sarnakar S/O Bholanath Sarnakar of Tulin Bartal, PS- Jhalda, Dist- Purulia and 15/20 (approx) unknown others showing agitation for giving shelter of migrant workers at Tulin Jai Siyaram High School and creating pandemonium and causing Traffic congestion and by making inconvenience to public. We requested and subsequently warned several times to remove the obstruction and to regularize the traffic flow. But they disobeyed our order as knowing us police personnel and having no pay heed our order they took dangerous way to obstruct public way. After several warnings, ultimately all the known and unknown persons among the mob who were causing obstruction, withdraw road blocked at about 11:15 Hrs and subsequently dispersed from the area. Though lockdown is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date- 24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- H & F W/120/20 dated 22.03.2020 which is extended till 03.05.2020. Later on the order is extended till 31/05/2020. Therefore they disobeyed Govt. order and committed negligent act likely to spread infection of diseases dangerous to life and violated Quarantine rule. So they committed offence and punishable U/S- 186/283/188/269/270/271 IPC and Read with section-18 of West Bengal High Way Act 1964 and 51 Disaster Management Act' 2005.

After arriving at Jhalda PS along with other officer and force I submitted this complaint to start a case U/S-186/283/188/269/270/271 IPC and Read with section-18 of West Bengal High Way Act 1964 and 51 Disaster Management Act' 2005 against all the aforesaid persons and 15/20 (approx) unknown others.
