

Sir.

In Producing here with 02 (two) arrested accd. Persons namely 1. Chinta Laya (28 Yrs.) S/O Falari Laya 2. Asutosh Mahato (19 Yrs) S/O-Bhajahari Mahato both of Village-Het-Jamlahar, P.S. Jhalda, Dist- Purulia brought under arrest with seized articles i) 02 (two) plastic Jaricans containing approx 15 (fifteen) ltrs. ID liquor in each Jarican total 30 (thirty) ltrs. ID liquor and ii) 01 (one) cycle from their possession. I do hereby lodged this written complain to the effect that on 06/05/2020 at 17:15 hrs. during evening mobile duty I received telephonic source information that two persons are carrying ID liquor from Jharkhand in one cycle and coming towards Het-Jamlahar village for selling (ID liquor) at Het-Jamlahar village. I inform the matter to I/C Jhalda P.S over Phone and as per his direction myself along with C/611-Jitandranath Pathak, NVF/39-Lalit Kishor Mahato and Dy. G.C/93- Jogen Singh Mura vide C.C No. 1396/2020 Dtd- 06/05/2020 left to work out the information. We reached near Mohuldih village on pitch road entrance point of Het-Jamlahar village at about 18:15 hrs. and started Naka checking and at 18:30 hrs. found 02 (two) persons coming towards Het-Jamlahar in cycle. We stopped them and searched. During search we found 02 (two) plastic Jaricans containing approx 15 (fifteen) ltrs. ID liquor in each Jarican total 30 (thirty) ltrs. ID liquor in their cycle. I asked them to produce for valid documents in respect of ID liquor. But they failed to produce any valid documents in respect of said ID liquor. During interrogation they disclosed their identity as noted above and confessed that they buy those ID liquor at Jharkhand and will sell from their houses at Het-Jamlahar village to the villagers in lieu of money. Accordingly I seized i) 02 (two) plastic Jaricans containing approx 15 (fifteen) ltrs. ID liquor in each Jarican total 30 (thirty) ltrs. ID liquor and ii) 01 (one) cycle under proper seizure list duly signed by the witnesses as well as accused persons with proper I search for local witnesses but none is there. I arrested them maintaining all formalities of arrest.

On return to P.S. along with accd. persons and all seized articles. Put the accd. persons in the Lockup after maintaining all formalities and seized articles kept in P.S. Malkhana and I pray a specific case may kindly be lodged against 1. Chinta Laya (28 Yrs.) S/O Falari Laya 2. Asutosh Mahato (19 Yrs) S/O-Bhajahari Mahato both of Village- Het-Jamlahar, P.S. Jhalda, Dist-Purulia and arrange for investigation.
