Sir,

I, SI Soumyadeep Mallick of Jhalda P.S. returned to PS with force and brought under seizure 1) One black colour Honda Livo Motor Cycle having No- WB56M/3048, 2) One black colour Pulsar Motor Cycle having No- JH08/3185, 3) One black and blue colour Super Splendor Motor Cycle without number plate having chassis No-MBLJAR166J9H13350 and 4) One black and blue colour Yamaha FZS Motor Cycle having No- JH01DQ/5228 and lodged this complaint against 1) Jiyaul Ansary (20) S/O Attab Ansary of Vill-Baghra, PS- Purulia (M), Dist- Purulia, 2) Jamir Ansary (20) S/O Giasuddin Ansary of vill-Palashbani, PS-Arsha, Dist-Purulia and 3) Sagir Ansary (19) S/O Giasuddin Ansary of do 4) Owner of Motor Cycle having No- JH08/3185, 5) Owner of Super Splendor Motor Cycle without number plate having chassis No-MBLJAR166J9H13350, 6) Owner of Motor Cycle having No- JH01DQ/5228 and others to the effect that today (06/05/2020) myself along with force C/382-Shibendu Sinha, C/1179- Pabitra Mandal was engaged in Spl. mobile duty. During Spl. Mobile duty as per direction we were engaged for implementation of Govt. rules regarding Lockdown and disaster management plan. At 19:25 Hrs. when myself with force was performing Naka checking at Birsha more under Jhalda P.S. above noted Motor cycles with three riders were detained as they were moving aimlessly and creating Halla. Three riders of Motor Cycle having No-WB56M/3048 could be apprehended but riders of other Motor cycles fled away leaving their Motor cycles on spot. We tried our level best to apprehend them but failed. I examined detained persons and during examination they disclosed their identity as noted above but they did not give proper reason why they came out from house and reached there. It is known that SI. No- 1) to 3) was riding in the Motor Cycle No-WB56M/3048. They could not produce any documents related to this Motorcycle having No-WB56M/3048. So, there is every reason to believe that the riders of those Motorcycles came out from their home and moving aimlessly or making fun and they did not came for emergency purpose. Though lockdown is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- H & F W/120/20 dated 22.03.2020 which is extended till 03.05.2020 and later on the order has been extended till 17.05.2020. Therefore they disobeyed Govt. order and committed negligent act likely to spread infection of diseases dangerous to life and violated Quarantine rule. So, I seized those Motor cycles with proper seizure list. I also arrested above noted accd. persons maintaining all formalities of arrest and later on released on bail considering present situation of epidemic COVID-19.

Therefore, I pray a specific case may kindly be lodge against 1) Jiyaul Ansary (20) S/O Attab Ansary of Vill- Baghra, PS- Purulia (M), Dist- Purulia, 2) Jamir Ansary (20) S/O Giasuddin Ansary of vill-Palashbani, PS-Arsha, Dist-Purulia and 3) Sagir Ansary (19) S/O Giasuddin Ansary of do 4) Owner of Motor Cycle having No- JH08/3185, 5) Owner of Super Splendor Motor Cycle without number plate having chassis No-MBLJAR166J9H13350, 6) Owner of Motor Cycle having No- JH01DQ/5228 and others as they disobey Govt. order and committed negligent Act likely to spread infection of diseases dangerous to life and violated Quarantine rule U/S 188/269/270/271/279 IPC and 51 Disaster Management Act, 2005 and arrange for investigation.
