Sir.

With due respect I SI Jayanta Maji of Joypur PS, beg to submit before you that on 02/05/2020 at about 16:55 hrs while myself along with force were performing mobile duty vide Joypur PS GDE No-52/20 Date-25/04/2020 & CC No-1786/20 Date-02/05/2020 and found the following person with his Motor Cycle, was roaming aimlessly at Baragram Bazar, Police party detained him at Baragram Bazar on Purulia-Bokaro pitch road (NH-32) under Joypur PS. On being asked the following person could not able to give any satisfactory answer for that movement on road and public place. On enquire it revealed that the person is the inhabitant of Jharkhand State and without any valid reason/valid pass he was moving at Baragram Bazar area. Though lockdown is going on throughout the District of Punilia in view of Pandemic of COIVD-19 outbreak. Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020. As such the following persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- H & F W/120/20 dated 22.03.2020 which is extended till 03.05.2020. Moreover the detained person was refuses to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic. The accused person also tried negligently to spared infection of disease dangerous to life. Accordingly the following person was arrested and seized 01 motor cycle from 17:15 hrs. to 17:25 hrs, under proper seizure list duly singed by the witnesses and the accused person, after maintaining all formalities regarding arrest and seizure & prepared arrest memos and brought them to P.S

 Lochan Majhi (45 yrs) S/o-Ananda Majhi of Kumardih, PS-Chandankiyari, Dist-Bokaro (JH). (Motor Cycle No-JH10AF-4982).

Hence it is prayed before you that above mentioned persons may kindly be prosecuted U/S 188/269/270 IPC & Read with section 51 of Pandemic Disaster Management Act, 2005.
